Course Information

Course Description	Instruction in the techniques used to analyze the fashion image of individual clients. Emphasis on personal coloring, seasonal color harmonies, appropriate fabric textures, body proportion and silhouette, figure, facial and hair analysis and wardrobe coordination. Study of fashion image consultant business practices and job qualifications.

Course Learning Outcome	<p>After the completion of this course, you should be able to:</p> <ol style="list-style-type: none"> 1. Demonstrate an understanding of the role of image in today's fashion culture. 2. Analyze the image of a particular social group or individual and communicate image related information with the class – utilizing a budget set forth upon project initiation. 3. Manipulate the elements of image to achieve a specific goal. <p>The primary purpose of this course is to broaden the perspective from which you view self image related to fashion. Much of what we will do in this course involves the application of color, self image and clothing/grooming aspects that impact the way people look and the perceptions associated with image. If you have studied these disciplines you will have an advantage over students who have not. If you have not studied any of them previously, you may find areas that you wish to pursue by doing further study.</p>

Beginning in Fall 2007, the Texas Legislature passed a law limiting first time entering freshmen to no more than SIX (6) total courses withdrawals throughout their educational career in obtaining a certificate and/or degree.
