Course Description: Private one-on-one voice lessons for the duration of one hour. Students will be coached on diction, voice technique, performance practice, acting and gestures, and background information of texts and music. Students will perform two selections in a voice/music department jury for the music faculty with an accompanist after the 16th week.

REQUIRED TEXT: Students are required to purchase a music book appropriate for that students (24 Italian Songs & Arias, G. Schirmer Edition, 50 Selected Songs in German, etc.) as well as The Inner Game of Music by Barry Green and W. Timothy Gallwey.

This course meets the core intellectual competencies of reading, writing, speaking, listening and critical thinking.

Course Goals/Objectives

To provide students a meaningful musical experience through the rehearsal and performance of quality vocal literature at the highest level possible; To provide students the opportunity to improve their individual singing skills while fostering proper technique and critical listening; To develop student's overall musicianship and encourage sharper sight-reading skills; To enhance student's taste and perception for certain styles and eras of music; To give students a perspective of a college/university setting and rehearsal/performance process, as well as a view of professional expectations; To give students a place to succeed, learn the benefits of hard work and teamwork, and enrich their life by a positive emotional experience though poetry and music.

Semester Three

Semester Four

Assume and maintain correct posture 85% of the time

Utilize correct breathing techniques 85% of the time

Use correct vowels and consonants 85% of the time

Sing with good intonation 85% of the time

Sing with note, rhythmic and word accuracy 85% of the time

Sing with good tone quality and correct diction 85% of the time

Demonstrate appropriate musical phrasing and style 85% of the time

Demonstrate good stage presence 85% of the time

The overreaching goal is to be able to:

- 1. Sing and perform art song, musical theater, and possibly opera with correct singer diction in English and other languages.
- 2. Produce a sound and assess the breath, phonation, and resonant space appropriate for the phrase.
- 3. Perform a song with the appropriate facial expression, text painting, gestures, and acting abilities free from tension and distraction.
- 4. Channel and harness thoughts and emotions to free from performance anxiety through practice, positive thoughts, and positive self-talk.
- 5. Perform a jury for the voice faculty at the end of the semester (session)—the performer chooses one song, the panel of faculty choose a second, followed by a few music/voice/career or education related questions.

Expectations Students will learn repertoire according to the following scale:

Prepared/Rehearsed Memorized

First semester: Five songs Three

Second: Six Four

Third/Fourth: 7-8 4-5

Students are expected to practice privately, either at school in the practice rooms, with the tutor, or at home, according to the following scale:

^{*}Repertoire is typically 2 English/American, 2 musical theater, 2 Italian. Second semester: add German. Third semester: add French.

First semester: 5-7 hours per week, minimum FIVE

Second: 6-8 hours per week, minimum SIX

Third/Fourth: 7+ hours per week

*Practicing does NOT include working on music for choir, or another music/singing class – it must be your private studio music.

ATTENDANCE IS MANDATORY! School policy states that a student who misses more than 12.5% of class time may be dropped from the class with a grade of F. Students who miss **more than FOUR** classes during the semester are subject to this policy.

WITHDRAWAL DATE: It is the responsibility of each student to formally withdraw from the class by 4:30 pm on April 3, OR THE COMPUTER WILL ASSIGN A GRADE OF F TO THE STUDENT.

INCOMPLETE GRADE POLICY: A grade of I (Incomplete) is reserved for students who are unable to complete the final exam or final week of studies due to extenuating circumstances such as serious illness, not for students who need to make up missed assignments.

Missed lessons: students are responsible for material presented. There will be no make-up lessons unless PRIOR arrangements are made with the instructor. If the instructor has to miss a lesson, it will be made-up.

TARDINESS: Class begins promptly at lesson time. Late entries into class are disruptive and impolite to those who come on time.

SCHOLASTIC DISHONESTY: cheating on a test, plagiarism and collusion as defined by HCC. Penalties include, but are not limited to, "0" on test or assignment in question, or "F" in the course.

Student Assignments

Assignments have been developed that will enhance your learning and develop your musical skills. To better understand a topic, you will be given assignments with key information that you will need to in your career as a musician. Students will be required to successfully complete the following:

- Look up background on composers, poets, singers, operas, musicals, or time periods and compositional styles as needed.
- Students are expected to PRACTICE their music outside of class, and to know their music EARLY ON in the rehearsal process.
- Students will be issued practice room cards, and will be expected to use them for practicing choir music as well as private lesson music.
- Plagiarism: Plagiarism is copying another student's work, or an already published work. It is also misquoting or not properly citing a source, and claiming it as your own, whether intentional or not. Students plagiarizing will be given one

warning and a lower grade, but will be given the opportunity to redo the assignment. Students who plagiarize a second time MAY BE WITHDRAWN FROM THE COURSE. Turnitin.com will help inform and student and aid them in how to properly cite sources and avoid plagiarism.

TURNITIN – Turnitin is a service through Canvas/Eagle Online where students submit their work and it is checked for plagiarism. If more than 15% of the work is plagiarized, students will be asked to edit the work or take a 50% the first time.

MAXIENT – Maxient is an online service where HCC professors can report plagiarism and cheating, and it will be linked to the students' permanent education record through the Dean of Students. If someone is caught cheating or plagiarizing, it will now be reported through Maxient.

A Grade of FX will be given to students who stop attending class; this distinction is made between a grade of F for poor performance in class.

GRADING:

HCC Grading System: 90-100=A, 80-89=B, 70-79=C, 60-69=D, 0-59=F

Grade breakdown: 80% for lesson and master class attendance, 20% for participation in and quality of final jury. Lack of a jury will result in an F in the course.

*A STUDENT WHO IS UNABLE TO COMPLETE A JURY WILL BE ASSIGNED AN INCOMPLETE UNTIL THE JURY IS MADE UP AT THE BEGINNING OF THE FOLLOWING SEMESTER. THE INCOMPLETE WILL TURN INTO A FAIL BY THE 15TH WEEK OF THE FOLLOWING SEMESTER IF A JURY IS NOT MADE-UP.

HCC Course Withdrawal Policy

If you feel that you cannot complete this course, you will need to withdraw from the course prior to the final date of withdrawal. Before, you withdraw from your course; please take the time to meet with the instructor to discuss why you feel it is necessary to do so. The instructor may be able to provide you with suggestions that would enable you to complete the course. Your success is very important. Beginning in fall 2007, the Texas Legislature passed a law limiting first time entering freshmen to no more than **SIX** total course withdrawals **throughout** their educational career in obtaining a certificate and/or degree.

To help students avoid having to drop/withdraw from any class, HCC has instituted an Early Alert process by which your professor *may* "alert" you and HCC counselors that you might fail a class because of excessive absences and/or poor academic performance. It is your responsibility to visit with your professor or a counselor to learn about what, if any, HCC interventions might be available to assist you – online tutoring, child care, financial aid, job placement,

etc. – to stay in class and improve your academic performance.

If you plan on withdrawing from your class, you **MUST** contact a HCC counselor or your professor prior to withdrawing (dropping) the class for approval and this must be done **PRIOR** to the withdrawal deadline to receive a "W" on your transcript. **Final withdrawal deadlines vary each semester and/or depending on class length, please visit the online registration calendars, HCC schedule of classes and catalog, any HCC Registration Office, or any HCC counselor to determine class withdrawal deadlines. **Remember to allow a 24-hour response time when communicating via email and/or telephone with a professor and/or counselor. Do not submit a request to discuss withdrawal options less than a day before the deadline. If you do not withdraw before the deadline, you will receive the grade that you are making in the class as your final grade.**

Repeat Course Fee

The State of Texas encourages students to complete college without having to repeat failed classes. To increase student success, students who repeat the same course more than twice, are required to pay extra tuition. The purpose of this extra tuition fee is to encourage students to pass their courses and to graduate. Effective fall 2006, HCC will charge a higher tuition rate to students registering the third or subsequent time for a course. If you are considering course withdrawal because you are not earning passing grades, confer with your instructor/counselor as early as possible about your study habits, reading and writing homework, test taking skills, attendance, course participation, and opportunities for tutoring or other assistance that might be available.

Classroom Behavior

As your instructor and as a student in this class, it is our shared responsibility to develop and maintain a positive learning environment for everyone. Your instructor takes this responsibility very seriously and will inform members of the class if their behavior makes it difficult for him/her to carry out this task. As a fellow learner, you are asked to respect the learning needs of your classmates and assist your instructor achieve this critical goal.
