Course Overview

Course Description

This course is an introduction to the fundamental concepts of managerial accounting appropriate for all organizations. Students will study information from the entity's accounting system relevant to decisions made by internal managers, as distinguished from information relevant to users who are external to the company.

The emphasis is on the identification and assignment of product costs, operational budgeting and planning, cost control, and management decision making. Topics include product costing methodologies, cost behavior, operational and capital budgeting, and performance evaluation.

- 2. Illustrate how to prepare a capital budget for service, merchandising and manufacturing companies
- 3. Illustrate how to prepare capital expenditure, financial budgets, and the master budget

Prepare an operating budget, identify its major components, and explain the interrelationships among its various components

1. Illustrate the relationship b/n sales *budget*, production *budget*, direct materials purchases *budget*, direct labor *budget*, overhead *budget*, ending finished goods Inventory *budget*, and cost of goods sold *budget*.

Explain the methods of performance evaluation.

- 1. Describe controllable and uncontrollable costs
- 2. Illustrate responsibility accounting systems
- 3. Illustrate financial and non-financial performance evaluation measures

Use appropriate financial information to make operational decisions

- 1. Illustrate financial performance measures such as return on investment, residual income, profit margin, and investment turnover
- 2. Illustrate the balanced scorecard, cycle time and cycle efficiency

Demonstrate the use of accounting data in the areas of product costing, cost behavior, cost control, and operational and capital budgeting for management decisions.

- 1. Describe job order costing, process costing, and activity-based costing
- 2. Illustrate cost behavior and cost-volume-profit analysis and variable costing
- 3. Compute payback period, net present value internal rate of return

All assigned exercises and problems in CONNECT are conceptually the same as the end of chapter exercises in your textbook except that CONNECT assignments are algorithmic variations giving different numbers for each student. Solutions to the original end of chapter exercises in your textbook are provided in Eagle Online and Connect for your reference. But you are advised not to 13 of 20 look at the solutions before you attempt them on your own.

Before attempting a graded assignment in Connect, read the chapter, and review other resources (PowerPoint, Connect Lecture videos in the Media Bank, LearnSmart, end of chapter exercises, etc.). You are encouraged to print the assignments, work offline, and go back to enter the answers. Click "Check my work" button on the bottom left side of the assignment page to find errors and correct it before submission. Use "Save and Exit" button to end a session, save your work and return to it at a later time before the due date. The "View Hint" links in some of the exercises allow you to watch a video of how similar exercises are done. All course assignments are open on the first day of class. Chapter assignment are shown in CONNECT. Click on "Submit Assignment" button only when you are ready to submit for grading. You are allowed up to two (2) attempts for all your homework assignments except for quizzes and exams. The best score of the two attempts goes to your grade book.
