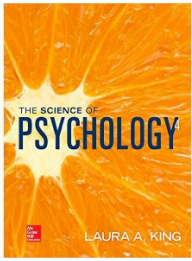

Course Overview

PSYC 2301 is a survey course of the basic principles underlying human behavior. Emphasis is placed on major areas of study in the field of psychology, such as motivation, development, thought processes, and personality.

Core Curriculum Objectives (CCOs)

PSYC 2301 satisfies the social science requirement in the HCCS core curriculum. The HCCS

Psychology Discipline Committee has specified that the course address the following core objectives:

- **Critical Thinking:** Students will demonstrate the ability to engage in inquiry and analysis, evaluation and synthesis of information, and creative thinking by completing a written assignment such as a book report, research paper, or essay.
- **Communication Skills:** Students will demonstrate effective development, interpretation and expression of ideas through written, oral, and visual communication by completing a written assignment such as a book report, research paper, or essay.
- **Quantitative and Empirical Literacy:** Students will demonstrate the ability to draw conclusions based on the systematic analysis of topics using observation, experiment, and/or numerical skills by completing textbook reading assignments, completing assignments, and answering questions on quizzes and exams.
- **Social Responsibility:** Students will demonstrate cultural self-awareness, intercultural competency, civil knowledge, and the ability to engage effectively in regional, national, and global communities by completing textbook reading assignments, completing assignments, and answering questions on quizzes and exams.

Student Success

The assignments provided will help you use your study hours wisely. Successful completion of this course requires a combination of the following:

Assignments, Exams, and Activities

Please carefully review all of the information in this section and don't hesitate to ask questions if anything is unclear to you. Be assured that I have thoughtfully designed all of the assignments, exams, and activities in this course to enable you to learn the material and to be successful. By providing due dates, I am helping you stay on track and accomplish your goal of getting the best grade you can in this course.

Written Assignment(s)

Students will be required to write one 3-5-page essay. The essay must be written in Times New Roman, double spaced, using 12-point font. The essay should be written on a theorist (e.g., Freud, Piaget, etc.) or theory of human behavior (e.g., psychoanalytic, cognitive, etc.). Please refer to the course student learning outcomes and learning objectives for topics. The writing essay assignment is worth 150 points. Students will be graded on five content areas: Introduction, content, personal perspective regarding the theorist/theory, conclusion, and grammar/style/flow. The maximum number of points that can be earned for each content

area is 30. Please refer to the Rubric in Eagle Online Canvas for complete scoring details. Essays will need to be submitted during class on or before the due date

Exams

There will be four exams in this course. Each exam will consist of 50 multiple-choice questions. The questions will be worth two points each for a total of 100 points. The four exams will collectively count as 400 points towards your course grade. Scantrons will be needed to take each exam. HCC does not provide students will scantron forms. Scantrons can be purchased in the campus bookstore.

In-Class Activities

Students are expected to participate in class. In-class activities consists of class participation and an individual presentation. Both are worth 100 points for a total of 200 points. For class participation, students will be graded on four areas: Contribution to class discussions, working with peers, preparedness for class, and attention and respect to others. The maximum number of points that can be earned for each area is 25. Please refer to the Rubric in Eagle Online Canvas for complete scoring details. Additionally, students will complete an in-class presentation. The presentation should be between 3-5 minutes and on a topic that is covered in class. Students will be graded on five areas: Knowledge of topic presented, creativity, organization, eye contact/voice, and time. The maximum number of points that can be earned for each area is 20. Please refer to the Rubric in Eagle Online Canvas for complete scoring details.

Other Assignments and Activities

There are no additional assignments or activities due for this class.

Practice Final Exam

All students will be required to take the Practice Final Exam. The practice exam will consist of 50 multiple choice questions worth one point each for a total of 50 points. The practice exam will be administered in class. You will need a Scantron for the exam. Please note that Scantron forms can be purchased in the campus bookstores.

Comprehensive Departmental Final Exam

All students will be required to take a comprehensive departmental final exam consisting of 100 multiple-choice questions. All the information students need to prepare for the exam is in the <https://learning.hccs.edu/programs/psychology/psyc-2301-departmental-final-exam-preparation-resources>. The exam will be administered in class on the date shown in the Course Calendar. Students must provide their own Scantron forms (FORM NUMBER 882-E-LOVAS). The final exam ***may not be taken early under any circumstances.*** The Comprehensive Departmental Final Exam will consist of 100 multiple-choice questions with each question being worth two points totaling a maximum of 200 points towards your total grade (1000 points maximum).

Students must correctly answer at least 50 of the 100 questions on the final exam (50%) to pass the course.

Students who are absent from the final exam must discuss their absence with the instructor in advance or within 24 hours afterward. Students who are absent from the final exam without discussing their absence with the instructor in advance or within 24 hours afterward will receive a course grade of Incomplete. Any student who does not take a makeup exam by the end of the following long semester will receive a final exam grade of zero and a course grade of F.

Instructor's Practices and Procedures

Missed Assignments

Assignments are due at the beginning of class. If an assignment is submitted late, an automatic ten points will be deducted from the grade. An additional ten points will be deducted for each day that the assignment is late. Students will be allowed to makeup exams on a case-by-case basis. Makeup exams are only allowed for missed exams. Makeups are not a retake of an exam.

Academic Integrity

Students are responsible for conducting themselves with honor and integrity in fulfilling course requirements. Penalties and/or disciplinary proceedings may be initiated by college district officials against a student accused of scholastic dishonesty. "Scholastic Dishonesty" includes, but is not limited to, cheating on a test, plagiarism and collusion. Any instance of scholastic dishonesty may be reported to the Maxiant system.
