**COURSE DESCRIPTION**: This is a course in human nutrition. Nutrients needed for good health are identified along with good sources of these nutrients. Nutritional needs are considered for all stages of the lifespan, along with weight management and food safety.

The goal of this course is to prepare students for careers that involve knowledge of nutrition and health of the human body and to help students to be able to choose healthy eating strategies for themselves and their families. The required textbook will provide information that the student will need to understand the complexity of human anatomy and physiology. We will be covering chapters 18 - 29over the course of the semester. <u>Math 0106 is a Biology prerequisite</u>. A&P 1 <u>and</u> General Biology I (Biology 1406) are highly recommended as prerequisites for this course. This course requires a basic understanding of biology, math, and chemistry.

- 3. Will demonstrate proficiency and safe practices in the use of laboratory equipment and basic laboratory techniques.
- 4. Will apply principles of the scientific method to problems in biology in the collection, recording, quantitative measurement, analysis and reporting of scientific data.

Completion of the specific Student Learning Outcomes listed below does NOT and will NOT guarantee the student any specific final course grade at the end of the semester!

- 1. Identify the functions of carbohydrates, fats, proteins, vitamins, minerals, and water, and be able to develop a healthy, well-balanced diet using the principles of choosemyplate.gov.
- 2. Calculate nutrient content and determine quality of food choices using information from food labels.
- 3. Explain the role of all essential nutrients in disease prevention and health promotion.
- 4. Identify physical fitness, body weight, and body fat as it relates to chronic disease.
- 5. Demonstrate how nutrient needs change for pregnant women, infants, children, adults and the elderly.
- 6. Analyze nutrition information using the scientific method.
- 7. Describe the methods of safe handling, preparation, and storage of food.

**\*\*OVERALL COURSE DESIGN:** This course is largely self-paced, as it is designed for your success while you study online. You are responsible for learning the information presented in the 7 Modules of your text, over which you will be assessed in an exam per Module over the course of the 16 weeks. For the online exams: I will open the information/work for each Module in MindTap, and then corresponding exam, for a defined time period. You are to complete the respective material (including any applicable HW or assignments, etc.), and then complete the associated "Lecture" exam(s), all on your own time schedule during that defined period. This design is such so that in this online self-paced course, you can be sure to complete your learning and mastery of the material. For the In-person Exam(s), you are to present to an identified testing center.

# **COURSE INFORMATION:**

This FULLY ONLINE/DE course is an integration of 3 PARTS: 1) a standard <u>Textbook</u>, 2) <u>online</u> <u>information</u> through Canvas, and 3) <u>online "Lecture" course Materials and Quizzes, Homework</u> <u>assignments and your Assessments/Exams</u> through the MindTap portal. NOTE: You are also required to take an In-Person Comp Final at an identified Testing Center. The online classroom portion includes notes on material covered in the textbook. These notes are not designed to be a comprehensive review, but rather an overview of the material covered in the text with added insights provided by your instructor.

# **COMMUNICATION:**

When you access the Canvas course, please <u>always check the Professor Announcements</u> forum link - the most up-to-date info will be posted there, and <u>you are responsible</u> for it.

We will communicate through the Professor Announcements on the Canvas course system, and by using the "Inbox" email feature found in the Canvas course. Email inquiries will be checked and answered once daily; however, I do not check email on Saturdays or Sundays – any emails generated on the weekend have no guarantee that they will be checked before Monday. It might be normal that I only answer emails once daily – please be patient. NOTE: In every email sent to me, please <u>include your CRN number</u>!!! Also keep in mind that I have office hours as well for those of you who wish to discuss coursework face-to-face.

## **COURSE SCHEDULE:**

A Calendar/Schedule for the course is posted/announced for you below to follow throughout the duration of the course.

Please NOTE: The course is organized into Modules, which track your chapters. <u>You will test at</u> <u>the end of</u> learning the material from <u>each Module</u>. HOWEVER, you will largely be afforded your <u>own pace</u> as follows: Your modules/information will be opened for a prescribed duration of time (approx. 3 weeks at a time); the Module Exams will be opened during the same time frame. This means that you can take the Exam at any point during that opening, whenever you feel comfortable with the material. The Exams are timed (giving you 2-3 minutes per question), and you only get <u>1</u> <u>chance to take</u> the exams. It is your responsibility to check the calendar, review the online information/<u>announcements</u>, and note any testing and schedule updates. (Note that some of the dates overlap.) NOTE: The Module Exams will "go live" for the 1<sup>st</sup> time approx. 1-2 weeks into the term, giving you time to get ensconced in the lecture material and assignments.

You must access the MindTap portal in order to progress through the course, via the link posted above on page 2 under Course Resources.

Please also plan for the last or next-to-last week/weekend of class when the DE department will be scheduling for your collective IN-PERSON Closed-Book Comprehensive Final Exam created by the HCC District – it is required for you to take In-Person (if you are out-of-city, then you will have to plan to take it at a proctored testing center, acceptable by our DE department – contact them with any questions). I will post the requisite logistics in the Canvas course.

#### **GRADE COMPUTATION:**

Course Grades will be based on percentages of points earned by the student, as follows:

- **7 Module Exam** grades, worth 100 points each will constitute <u>60%</u> of the students' grades.
  - Students MUST take <u>all</u> module exams **they are all** <u>**mandatory**</u>. If an exam is missed, the student will receive a zero that will be included in the average.
- <u>10%</u> of the grade will be based upon student completion of **Quizzes &/OR Case Studies** sprinkled throughout the Course Modules.
- <u>20%</u> of the grade will be earned by participation in posted **Activities and/or Homework** – some of this might be GROUP work.
- **<u>10%</u>** of the grade will be determined by performance on the **Comprehensive Final**.
  - The HCC Science Discipline requires a System-wide Comprehensive Final for each science course. You are <u>required</u> to take it in-person during the weekend of Dec. 9<sup>th</sup> and 10<sup>th</sup>. When the Testing Centers schedules the Comp Final locations, I will notify you via announcement/email.

Some of the Modules have all of the items listed above; some do not. Whatever is posted for each is what you will be asked to complete. Do not worry if it is not the same for each Module.

**Potential for Extra credit:** There may be an opportunity for bonus during the term, which can improve your earned course grade by up to a maximum of 5%. Bonus opportunities in the past have included Library Resources material, visits to city museums for specifically identified exhibits, and participation in Science club and other campus organizations/presentations. When/if such opportunities arise, I will post them under the Professor Announcements on Canvas with applicable instructions for completion.

\*\*A grade of "FX" is assigned to students who stop attending class but do not withdraw before the deadline; such grade is treated the exactly the same as a grade of "F" in terms of GPA, probation, suspension, academic progress, and Financial Aid.

The course chapter exams are conducted on-line via personal computer or at any HCCS Computer Laboratory within a specified time frame. Please allow adequate time to complete your exams and to resolve any unanticipated personal computer or networking problems. Any chapter exam that is not completed on time will be considered a missed exam. <u>Missed exams will be graded as zero,</u> and there are no makeup exam opportunities for missed online exams.

If your personal computer has a history of technical or networking problems, it is highly recommended that you plan to use an HCCS Computer Laboratory to complete your online exam. Online courses require students that are capable of budgeting time efficiently and managing the exam time limit wisely.

Please note that **poor planning, personal computer or networking problems are <u>unacceptable</u> <u>excuses</u> for missed online exams. In fairness to other students, any missed exams will be counted as 0 points, meaning that when computing your final grade, missed exam points (0 out of 100 available points) will be averaged into your other grades. A grade of zero will greatly jeopardize your final grade and may cause you to get an undesirable grade or fail the entire course.**

# SUCCESS TIPS:

It is the student's responsibility to:

- Participate in the class and complete learning activities
- Read and comprehend the textbook

- Ask for help when there is a question or problem

#### To be successful in this class:

1. Read the text and use the resources provided online by publisher.

2. Study material after reading or computer exercises. Make pictures, lists, flow charts, flashcards – whatever works FOR YOU. Review the reading, notes, power-point lectures before tests.

3. Make connections between chapters such as concepts learned in one chapter with concepts covered in another chapter by flipping back and forth in the text as you study.

4. Review the course **objectives** and use them as a checklist before exams to ensure you have the skills that will be tested. Also, ask yourself the general question, <u>*How*</u> does this work? If you can explain processes, you know that you have the facts, vocabulary, details and overall understanding you need.

5. Review the previous week's material when you finish the assignment for that week – don't forget that you have a Comprehensive IN-PERSON closed-book final during the weekend of Dec. 9<sup>th</sup> and 10<sup>th</sup>!

6. Keep up on everything, and don't get behind.

Develop a curious attitude. Read and learn all you can about the role of good nutrition in health. It will help you and your family to live a healthier, and possibly even longer, life.

#### **RULES & REGULATIONS;**

#### Adult behavior is expected online in the virtual classroom.

This instructor is committed to a high standard of academic integrity in the academic community. When there is clear evidence of cheating, plagiarism, collusion, or misrepresentation, disciplinary action may include but is not limited to requiring you to retake or resubmit an exam or assignment, assigning a grade of zero or "F" for an exam or assignment; or assigning a grade of "F" for the course. Additional sanctions including being withdrawn from the course, program or expelled from school may be imposed on a students who violate the standards of academic integrity.

#### **REPEATING COURSES (THREE-PEAT RULE)**

As a result of recent Texas legislative changes, please be advised that HCC is charging additional tuition for students who enroll in the same class three or more times at HCC. While it is the hope of HCC that students will be successful in their first attempt at classes, we realize that life demands, academic struggles, and other issues may result in students needing to take the same class more than once. Speaking with an advisor will help you develop student success skills, improving your overall academic performance. If a student repeats a course in which a grade (A-F) has been received, the highest grade received at HCC is the permanent grade for the course and will be used in computing the GPA. All grades earned in a given course will be reflected on the transcript. Other colleges may compute the GPA differently than HCC.

#### HCC COURSE WITHDRAWAL POLICY

Students must withdraw by the withdrawal deadline in order to receive a "W" on a transcript. Final withdrawal deadlines vary each semester and/or depending on class length, please visit the online Academic Calendar, any HCC Registration Office, or any HCC advisor to determine class withdrawal deadlines.

Be certain you understand HCC policies about dropping a course and consult with a counselor/advisor to determine if withdrawing is in your best interest. It is your responsibility to withdraw officially from a class and prevent an "F" from appearing on your transcript. Senate Bill 1231 limits the number of W's a student can have to 6 classes over the course of their entire academic career. This policy is effective for students entering higher education for the first time in fall 2007 and subsequent terms. Withdrawals accumulated at any other Texas public higher education institution count toward the 6 course total. Withdrawals for certain circumstances beyond the students control may not be counted toward the 6-drop limit.

In addition, withdrawing from a course may impact your financial aid award or eligibility. Contact the Financial Aid Office or website to learn more about the impact of withdrawing on financial aid.

An instructor will **no longer give a grade of "W"** to any student after the **official drop date – this** is the student's responsibility.

# HOW TO DROP

- If a student decides to withdraw from a class upon careful review of other options, the student can withdraw online prior to the deadline through their <u>HCC Student Center.</u>
- HCC may withdraw students for excessive absences without notification.
- Students should check HCC's Academic Calendar by Term for withdrawal dates and deadlines. Classes of other duration (flex-entry, 8-weeks, etc.) may have different final withdrawal deadlines. Please contact the HCC Registrar's Office at 713.718.8500 to determine mini-term class withdrawal deadlines.
