COURSE OVERVIEW

Course Description: A course of study covering the structure and function of the Endocrine, Cardiovascular, Lymphatic, Immune Systems and the Body's Defenses, Respiratory, Urinary, Fluid and Electrolytes, Digestive, Nutrition and Metabolism, Reproductive Systems and Development, Pregnancy and Heredity.

Students are encouraged to invest approximately 2-3 hours of study time for each hour of class time to master the material. The class and study time necessary to succeed in this class will be close to 300 hours (20 hours per week). Pay careful attention to lab work and models in the lab. You need to know these to do well in your lab exams.

Course Prerequisites: College Level Reading as determined by SAT, ACT, TASP or successfully passing ENGL0305 with "C" or better. Biology 1406 (General Biology) is strongly recommended.

Course Goals: This course is intended for students majoring in one of the physical sciences or life sciences, engineering, or for students who are pursuing pre-professional programs in medicine, dentistry, pharmacy,

veterinary medicine, or other health programs. The course is also beneficial to students who are preparing themselves for higher-level science courses in their respective curricula.

Core Objectives

BIOL 2302 fulfills the requirement for the Life and Physical Sciences Foundation Component Area of the Core Curriculum. Like other courses in this category, it focuses on describing, explaining, and predicting natural phenomena using the scientific method. It involves the understanding of interactions among natural phenomena and the implications of scientific principles on the physical world and on human experiences. As such, it targets the following Core Objectives:

- 1. Critical Thinking (explain how)
- 2. Communication (explain how)
- 3. Empirical and Quantitative Skills (explain how)
- 4. Teamwork (explain how)
- Critical Thinking Skills (CT) creative thinking, innovation, inquiry, and analysis, evaluation and synthesis
 of information
- Communication Skills (COM) effective development, interpretation and expression of ideas through written, oral and visual communication
- Empirical and Quantitative Skills (EQS) manipulation and analysis of numerical data or observable facts resulting in informed conclusions
- Teamwork (TW) ability to consider different points of view and to work effectively with others to support a shared purpose or goal"

- 1. Will display an understanding of biological systems and evolutionary processes spanning all ranges of biological complexity, including atoms, molecules, genes, cells, and organisms.

- 3. Will demonstrate proficiency and safe practices in the use of laboratory equipment and basic laboratory techniques.

- 1. Use anatomical terminology to identify and describe locations of major organs of each system covered.
- 2. Explain interrelationships among molecular, cellular, tissue, and organ functions in each system.
- 3. Describe the interdependency and interactions of the systems.
- 4. Explain contributions of organs and systems to the maintenance of homeostasis.
- 5. Identify causes and effects of homeostatic imbalances.
- 6. Describe modern technology and tools used to study anatomy and physiology.

College reading level as determined by SAT, ACT, TASP, or successfully passing ENGL 0305 with a "C" or better.

Although BIOL 1406 is not a required prerequisite for BIOL 2301, it is highly recommended to understand some of the key concepts taught in this course.

<u>Student Assignments</u>: There are two different sets of assignments in this course;

- <u>Graded Assignments</u>: All deadlines for the graded assignments are in the syllabus and have to be completed in a timely manner.
 - <u>Learnsmart Assignments</u> (10% of the total Grade online submission): Please check publisher's Adaptive online assessments. These assignments are meant to help you understand chapter content.
 - <u>Lecture exams (70%</u> of the total Grade): There will be a total of four lecture exams worth 100 points each. The questions will be primarily multiple choice, true or false, fill in the blank, and picture identification.
 - Special Project Assignment: This is the second type of assignment will require library research and will be developed by the instructor. Specific instructions will be provided on the assignment when released close to the middle of the semester. 10% of Final Grade
 - <u>Final Exam</u> (10% of the course): is mandatory for all students. This is a comprehensive final exam including all chapters covered in the course and is a requirement of the Biology Discipline at HCC.
