Course Description:

This introduction to the visual arts is a global investigation of artistic styles, methods of artistic production and media. Various works will be analyzed and defined in relation to the formal elements and the principles of design. Universal themes are studied within their historical, political, economic, theological, sociological, conceptual, and ethnic contexts. Students will also develop critical thinking and observational skills through the creation of hands-on art projects. A general introduction to the visual arts designed to create an appreciation of the vocabulary, media, techniques, and purposes of the creative process. Students will critically interpret and evaluate works of art within formal, cultural, and historical contexts. (ACGM 2016)

- 2.4 Evaluate formal characteristics of two or three dimensional art and then develop critical analyses through discussions, journals, presentations, and essays.

3. Differentiate between the processes and materials used in the production of various works of art.

- 3.1 Identify artistic media including: drawing, painting, sculpture, architecture, printmaking, textiles, ceramics, metal arts, photography, and digital arts.
- 3.2 Compare and contrast methods of production and processes.
- 3.3 Classify and examine technological development of artistic media demonstrated by the selected artworks.
- 3.4 Select and use appropriate materials, techniques and processes in a hands-on art project(s).

4. Critically interpret and evaluate works of art.

- 4.1 Employ vocabulary terms while interpreting and evaluating works of art.
- 4.2 Examine the functions of art within various cultures and time periods.
- 4.3 Compare and contrast the function of art within various cultures and time periods.
- 4.4 Evaluate the relationship of form to function of selected artworks in their historical context.

5. Demonstrate an understanding of the impact of arts on culture.

- 5.1 Analyze the way the role of the artist has changed over time.
- 5.2 Compare and contrast the roles of artists' audiences and patrons.
- 5.3 Appraise the effects of various social, political, technological, ethnic and theological forces on artists within selected periods.
- 5.4 Interpret the significance of selected artworks within their broader cultural context and then develop critical analyses through discussions, journals, presentations, and essays.

Core Curriculum Objectives:

- Critical Thinking Skills [HCC: to include creative thinking, innovation, inquiry and analysis, synthesis of information] Art Appreciation is an investigation and analysis of the styles and modes of artistic production from Prehistoric times to our own. Through the study of artistic media, universal themes are explored and students will develop an appreciation for the creative process as one that represents an evolving synthesis of cultural, personal, and technological influences. Assessment of critical thinking in course work will count for no less than 10% of the final grade.
- 2. Communication Skills [HCC: to include effective development, interpretation and expression of ideas through written, oral, and visual communication]

Art Appreciation students will learn to interpret the language of visual communication through the study of selected artworks and *creation of their own hands-on art project*. Students will demonstrate effective writing skills as they fulfill instructor specific writing assignments. In addition, students will develop verbal communication skills as they participate in discussions, critiques and presentations throughout the semester. Assessment of verbal and written communication in course work will count for no less than 10% of the final grade and may be combined with other core assignments.

3. Teamwork [HCC: to include the ability to consider different points of view and to work effectively with others to support a shared purpose or goal]

In Art Appreciation courses we use discussions, critiques, group assignments and hands-on art projects to analyze artistic production within various cultures and time periods. This exploration of culture through art allows students to connect with a variety of viewpoints and then exchange viewpoints with others. Students will demonstrate their ability to work effectively with others in class as they safely and responsibly manage shared media, tools, equipment and clean-up duties, as applicable. Each semester students will *participate in at least one collaborative assignment* designed to expand their experience in developing skills essential to working effectively with others to support a shared purpose or goal. Assessment of teamwork activities and assignments will count for no less than 10% of the final grade and may be combined with other core assignments.

4. Social Responsibility [HCC: to include intercultural competency, knowledge of civic responsibility, and the ability to engage, effectively in regional, national, and global communities]

By its very nature Art Appreciation is intercultural. As a subject it explores various historical, political, economic, theological, sociological, and ethnic contexts. Using this framework, students consider the community's responsibility in such issues as art destruction/defacement and restoration, art acquisition and public display, public funding of art and censorship. Students observe current events and how they influence or change art history, as new discoveries may change our perception about art. Students make use of the local art community (including museums, galleries, etc.) to augment their knowledge of and participation in their community. Assessment of social responsibility activities and assignments will count for no less than 10% of the final grade and may be combined with other core assignments.

Core Curriculum Assessment:

Students will work in teams to explore and analyze a given topic that deals with how an aspect of visual art and social responsibility relate. Student teams will then create a written, oral, and visual project that effectively communicates the given topic. The responsibility of each team member is to research and analyze the gathered material, and contribute to the creation of the resulting project. Each team is responsible for submitting a written, oral, and visual project that outlines their findings, analysis, and interpretation of the material.

Instructional Methods:

Methods of instruction in this course may include: lecture, media/video/film presentations, media and technique demonstration, handson art project work time, readings (from textbooks, peer reviewed articles, books and original source seminal texts), field trips, discussions and critiques. All methods, selected, are designed to foster creativity, as well as incorporate life-long skills (cooperation, collaboration, communication, critical thinking, research, social responsibility, writing...) that will help you in other classes, your career, and personal life.

Certain course materials may be placed on the HCCS Eagle Online Art 1301 course supplement, upon discretion of instructor and approval of the HCCS Art Department. Students are responsible for accessing Eagle Online course materials as well as attending class at South Campus (Willie Lee Gay Hall), Room #103, on T/TR at 11:00 – 12:30 pm, throughout the semester.

Disclaimer: Due to the nature of course content, some controversial themes, as well as nudity, may be featured in this class. If you feel uncomfortable with the course subject matter, it's your responsibility to withdrawal from the course. Guests and/or children are not allowed in the classroom. All electronic devices must be turned off and put away, unless otherwise instructed. Disruptive students will be asked to leave the classroom, as well as be marked absent for each incident, which may result in withdrawal or failure of course.

Student Assignments:

Assignments containing directions, grading criteria, and due dates, are distributed to students, during class period, throughout the semester. It is the students responsibility to obtain assignments, as well as submit completed assignments, by schedule due dates. Late or make-up assignments are not accepted in the course. Instead, extra credit opportunities are offered throughout the semester. Students who miss a class are responsible for sending assignment(s) to instructor by original scheduled due date/time, otherwise, will not receive points for assignment(s). Emergency situations are handled on an individual basis. Example of an emergency situation: Student is hospitalized or being treated by a professional for a physical and/or psychological illness. Student must provide instructor with official documentation from the HCCS Disability/Ability Support Service Office. Instructor approval of documentation must be granted prior to issuing or accepting an extension or modification of an assignment. Accommodations are not granted for computer and/or human error, personal or professional issues, vacations or illness, nor are make-up assignments issued.

Assignments/Activities may include: group and/or individual creative projects, written critical responses, critiques, unannounced quizzes, exams, hands-on studio work, online and/or in-person gallery visits, various assigned readings from textbooks, peer-reviewed articles, books, original source seminal texts; mandatory discussions based on various topics related to the major areas of study in Art and Design and the major time periods of study in Art History; writing short papers including critiques, essays, analyses, reviews, research, comparing and contrasting artistic or design theories and Art Historical perspectives; student presentations; service learning projects; group and/or individual projects; portfolios, field work, collaboration, peer teaching; other methods as may be determined by individual instructors. This course requires a minimum of 2000 words in a combination of writing assignments and/or projects. This course requires one studio project and one team project.

Student Assessments:

Methods of Assessment/Evaluation may include: hands-on art projects; portfolios; creative projects; tests and quizzes which may include: definitions, matching, multiple choice, true/false, short answer, brief essay, essay, lists; writing assignments; in-class discussions and/or critiques; written papers including critiques, essays, analyses, reviews, research, comparing and contrasting artistic or design theories and Art Historical perspectives; presentations; group and/or individual projects; service learning projects; other methods as may be determined by individual instructors.

- Explain the function and significance of art within its historical and cultural contexts
- Complete a hands-on art project which demonstrates knowledge of the elements and principles of design

Additional requirements for Honors students:

Honors students will write an additional 2,000 words. They will complete a project or oral presentation that shows a higher level of analytical thinking and satisfies the requirement of the honors contract

Final Grade of FX: Students who stop attending class and do not withdraw themselves prior to the withdrawal deadline may either be dropped by their instructor for excessive absences or be assigned the final grade of "FX" at the end of the semester. Students who stop attending classes will receive a grade of "FX", compared to an earned grade of "F" which is due to poor performance. Logging into a DE course without active participation is seen as non-attending. Please note that HCC will not disperse financial aid funding for students who have never attended class. Students who receive financial aid but fail to attend class will be reported to the Department of Education and may have to pay back their Financial Aid. A grade of "FX" is treated exactly the same as a grade of "F" in terms of GPA, probation, suspension, and satisfactory academic progress.

IP (In Progress) is given only in certain developmental courses. The student must re-enroll to receive credit. COM (Completed) is given in non-credit and continuing education courses.

The grade of "W" (Withdrawal) appears on grade reports when students withdraw from a class by the drop deadline. Instructors have the option of dropping students up to the deadline. After the deadline, instructors do not have that option — not even when entering final grades.

The grade of "I" (Incomplete) is conditional. It will only be assigned if at least 80% of the course work is complete. Students receiving an "I" must make an arrangement with the instructor in writing to complete the course work within six months. After the deadline, the "I" becomes an "F." All "I" designations must be changed to grades prior to graduation. Changed grades will appear on student record as "I"/Grade (example: "I/A"). **Note: Not issued in this course.**

- ✓ Teamwork: Collaboration with Peers (several assignments/activities incorporate either partnership or group work)
- ✓ Social Responsibility: Attend Museum & Gallery Field Trips to develop intercultural competency, knowledge of civic responsibility and engagement within diverse artistic communities.

Grades are manually recorded, as well as digitally recorded within the EO/Canvas online course gradebook. Individual grades are accessible to students, during the term, via the course EO/Canvas gradebook, when available. It is a student's responsibility to monitor their course progress throughout the term. All EO/Canvas online course contents are permanently recorded, archived for future reference by instructor and/or HCCS Administration, and remain the legal property of HCCS, as well as instructor of the course.

- 1. Make-up assignments are not issued in this course. It is your responsibility to contact instructor for assignments distributed in your absence, as well as submitting completed assignments by scheduled due dates.
- 2. Make-up Exams (Mid-Term & Final) are not issued in this course. Incompletes are not issued in this course.
- 3. Periodically, <u>unannounced Quizzes</u> may be issued for extra credit points; students <u>must be in attendance to earn extra credit</u> <u>points</u>. Make-up quizzes <u>are not</u> issued in this course.

Instructional Materials:

- Textbook: <u>A World of Art</u>, 8th Edition, Henry Sayre, Pearson/Prentice Hall, 2016. A textbook is required at the beginning of the semester when classes begin. You are expected to bring course textbook to each scheduled class meeting. Visit HCCS Bookstore, Local Bookstore, Library, or Publisher online. You may also obtain the 7th edition, but not an older version due to textbook content errors and/or additions. If you don't have a course textbook, you will need to use computer technology (Internet Browser Required) in the classroom or use computers at the library or computer room located on campus. Be aware that online material might not include specific content featured in the course/course textbook.
- Studio Art Supplies: A Studio Assignment is featured in this course. Students are responsible for purchasing necessary supplies (approximately \$10.00 \$20.00). Supply list is published prior to assignment's lesson. Central Campus open studio hours (subject to change): M-TH: 8a.m 9:30 pm; F-Sa: 8 am -3:30 pm.
- 3. File Formats: When uploading files to Eagle Online /Canvas, or submitting files to instructor via e-mail, only the following formats are accepted: .pdf, .rtf, .doc, .docx, jpeg. Documents submitted in alternate formats are not accepted due to digital program constraints.

Lab Requirements: Students can expect to incur the cost of their own art supplies, approximating \$10.00 to \$20.00 (or more) over the course of the semester. Most supplies can be found at discount or department stores (Walmart, Target, Dollar General...). Examples of art supplies that may be necessary for this course: glue, scissors, tape, craft paper, poster board, markers, colored pencils, modeling clay...supply list to be distributed prior to assignments. Students are expected to clean-up after themselves and practice safety if, and when, working on art projects during class period. Any student who does not adhere to these expectations will either receive zero points for their assignment, be removed from the classroom, and/or may be withdrawn from and/or fail the course. **Open Studio Schedule:** Central Campus open studio hours (subject to change): (M-TH: 8a.m – 9:30 pm; F-Sa: 8 am -3:30 pm).

Health Safety: In this course, students will use diverse art media and techniques, as well as visit an art museum or gallery during the course of the semester. Certain art forms contain chemicals that may be hazardous to one's health. It is strongly advised that if you are pregnant, have respiratory difficulties, sensitivity to chemicals or art media (such as acrylic or oil paint, charcoal, glue, clay, tape...) or have hand or wrist problems, you should not stay enrolled in this course.

Insurance Disclaimer: The Fine Arts Department at Central College strongly recommends that all HCCS students carry some form of medical insurance to cover illness and injury, both on and off campus. Information regarding low-cost health insurance for students is available in the Fine Arts office. Under Texas state statute, HCCS is immune to liability in the event of accident or injury.

Rules of Conduct: Students are expected to behave appropriately, while in the classroom, conducive to a productive classroom environment. This includes paying attention during class period and behaving, appropriately, while in the classroom. I. Student may also be asked to leave the classroom and/or be removed from the classroom by security or instructor, and/or may be removed from and/or fail the course. Students suspected of bringing a weapon into the classroom, are inebriated, or extremely disruptive, will immediately be removed from the classroom by a security guard or police officer. Each incident is permanently recorded and submitted to the HCCS Counseling Department, Campus Security, as well as the Art Department Dean. Each incident is handled on an individual basis. Instructor has authority to determine appropriate consequence for Inappropriate Behavior exhibited in the classroom.

HCC Policy Statement: Academic Honesty:

You are expected to be familiar with the College's Policy on Academic Honesty, found in the catalog and student handbook. Students are responsible for conducting themselves with honor and integrity in fulfilling course requirements. Penalties and/or disciplinary proceedings may be initiated by College System officials against a student accused of scholastic dishonesty. "Scholastic dishonesty" includes, but is not limited to, cheating on a test, plagiarism, and collusion.

Cheating on a test includes:

- Copying from another student's test paper;
- Using materials during a test that are not authorized by the person giving the test;
- Collaborating with another student during a test without authority;
- Knowingly using, buying, selling, stealing, transporting, or soliciting in whole or part the contents of a test that has not been administered;
- Bribing another person to obtain a test that is to be administered.

Plagiarism means the appropriation of another's work and the unacknowledged incorporation of that work in one's own written work offered for credit.

Collusion means the unauthorized collaboration with another person in preparing written work offered for credit.

Violations: Possible punishments for academic dishonesty may include a grade of "0" or "F" on the particular assignment, failure in the course, and/or recommendation for probation or dismissal from the College System. A recommendation for suspension or expulsion will be referred to the College Dean of Student Development for disciplinary disposition. Students who wish to appeal a grade penalty should notify the instructional supervisor within 30 working days of the incident. A standing committee appointed by the College Dean of Instruction (Academic or Workforce) will convene to sustain, reduce, or reverse the grade penalty. The committee will be composed of two students, two faculty members, and one instructional administrator. A majority vote will decide the grade appeal and is final.

Official HCC Attendance Policy:

Students are expected to attend classes regularly. Students are responsible for material covered during their absences, and it is the student's responsibility to consult with instructors for makeup assignments (if issued). Class attendance is checked daily by instructors.

In this course, students who arrive 20 minutes late to class, or leave early, are marked absent unless student provides instructor with documentation of emergency situation warranting late arrival/early dismissal. Each incident is handled on an individual basis.

Although it is the responsibility of the student to drop a course for non-attendance, the instructor has the authority to drop a student for excessive absences. A student may be dropped from a course for absenteeism after the student has accumulated absences in excess of 12.5 percent of the hours of instruction (including lecture and laboratory time). For example: For a 3 credit lecture class (Art Appreciation & Art History) meeting 3 hours per week (48 hours of instruction), a student may be dropped when their absence exceeds 6 hours (4 class periods for this particular class). Note: Late or make-up work is not accepted in this course. It is a student's responsibility to obtain assignments, in their absence, and submit completed assignments by scheduled due dates. Course Withdrawals-First Time Freshmen Students-Fall 2007 and Later:

Effective 2007, section 51.907 of the Texas Education Code applies to first-time in college freshman students who enroll in a Texas public institution of higher education in the fall semester of 2007 or thereafter. High school students currently enrolled in HCC Dual Credit and Early College are waived from this requirement until they graduate from high school.

Based on this law, HCC or any other Texas Public institution of higher education may not permit students to drop after the official day of record more than six college level credit courses for unacceptable reasons during their entire undergraduate career.
