Course Description

Origin and development of the Texas constitution, structure and powers of state and local government, federalism and inter-governmental relations, political participation, the election process, public policy, and the political culture of Texas

Prerequisite, Co-requisite

Must have passed or co-enrolled in English 1301 (Composition I) as a co-requisite.

1. Explain the origin and development of the Texas constitution.

2. Describe state and local political systems and their relationship with the federal government.

3. Describe separation of powers and checks and balances in both theory and practice in Texas.

4. Demonstrate knowledge of the legislative, executive, and judicial branches of Texas government.

5. Evaluate the role of public opinion, interest groups, and political parties in Texas.

6. Analyze the state and local election process.

7. Identify the rights and responsibilities of citizens

Course Student Learning Outcomes (SLO)

1. Identify and describe the institutions of the State of Texas government.

2. Identify and evaluate information sources for political news, data, and opinion.

3. Analyze the effects of the historical, social, political, economic, and cultural forces on politics and government.

Core Objectives

Social Responsibility—to include the ability to connect choices, actions, and consequences to ethical decision-making

Student assessment of proficiencies mandated by THECB may include testing, projects, or assignments.

Technical Requirements

This class is a distance education course that requires coursework be completed using the Houston Community College System's Eagle Online 2. Instructional delivery of course content, materials, assignments and information is done 100% online. Each student must maintain Internet access throughout this course. NO late, make-up or extensions will be granted.

Failure to maintain internet access will not excuse incomplete, failed or missed submissions of assignments. The impact will significantly affect student's academic success, and lead to a reduction in grade for this course. Student Assignments & Instructor Grading Criteria

20% Quizzes There are a total of 5 quizzes to be completed in this course. Students have 3 attempts at each quiz. The module content materials and book chapters that each quiz will test can be found by reviewing the each of the quizzes links within the Quiz Folder, in Eagle Online.

There is a 45 minute time limit on each attempt. Students cannot start, then pause their once they begin. The highest graded attempt will be recorded in the grade book and count towards the final course average. No make-up or extensions will be granted.

20% Reflective Writings Students will complete a total of 5 reflective writings. Instructions on how to complete each reflective writing are located in the Reflective Writing Folder, within Eagle Online.

Reflective writings are to be written in essay format, double spaced, with paragraphs, using complete sentences, proper grammar, 12 point font in Times New Roman. Writings must be a minimum length of 2 pages, and formatted with 1 inch margins.

All submissions are required to provide in-text (parenthetical) citations, as well as either a bibliography or works cited page. Works cited and bibliographies do not count toward the 2 page length requirement.

Works cited and Bibliographies and writing assignments are to be uploaded as a single file. You only have one attempt and can make one upload to submit your paper to the links provided. You may use MLA, APA or Chicago formatting, as long as you remain consistent through your paper, in-text citations and bibliography/works cited pages.

Grading Requirements

Assignments that fail to meet the above formatting requirements. Submissions indicated by Turn It In to have a 50% or greater match with content from any publications, online resources, scholarly works, or student submissions, and that lack proper in-text and bibliographic citations.

No make-up, extensions, or resubmissions will be accepted. No exceptions.

Reflective writings must answer directly the prompt or discussion topic, provided in the instructions. Responses should provide a critical assessment or pose an argumentative political position towards the prompt or discussion question. Purely summarizing the materials in response to the question or topic will be considered an average response and receive no higher than a grade of a 70.

Above average responses should provide at least one independently researched resource, as well as include example(s) from the materials, to show support of the student's assessment or

political position.

30% Current Event Article Discussions Students will participate in 2 separate current event class discussions. There are two parts to each discussion. Current events must be pertinent to one of the 12 American Government Topics assigned in this course. To be current, articles must be retrieved within the last 3 months.

Part 1- students will find a current event related to topics in Federal Government, the U.S. Constitution or American Politics. Students will post a 10 sentence summary analysis of the information in the article by providing a clear opinion statement and discussion of their personal perspective and political position towards the event or issue in their article. In addition, to receive full credit, students MUST include a direct link to the original article's text that they are using to complete this assignment.

Part 2- (cannot be completed until students first submit part 1) students will review summary analyses submissions, made in part 1, and select at least one to write a rebuttal to. Students must choose a submission from a political position and perspective that opposes their feelings toward the event or article, posted by their peer. Rebuttals must be 5-10 sentences in length, and must post with an opposing political perspective.

30% Exam The module content materials and book chapters to be tested on can be found by reviewing the each Exam link within, in Eagle Online.

Students will have 2 attempts at each exam. Exams must be completed and submitted within a 2 hour time limit. Exams will be comprised of multiple choice and true false questions, based on the information from the module content materials that they are assigned.

No due date extensions will be granted, and no make-up exams will be given.

Repeating Courses:

As a result of recent Texas legislative changes, please be advised that HCC is charging additional tuition for students who enroll in the same class three or more times at HCC. While it is the hope of HCC that students will be successful in their first attempt at classes, we realize that life demands, academic struggles, and other issues may result in students needing to take the same class more than once. Speaking with an advisor will help you develop student success skills, improving your overall academic performance. If a student repeats a course in which a grade (A-F) has been received, the highest grade received at HCC is the permanent grade for the course and will be used in computing the GPA.
