## CORE CURRICULUM OBJECTIVES ART

**1. Critical Thinking:** Assignments, students are directed to analyze, compare, discern or interpret aspects of art. Through critiques and peer reviews the student's success is measured.

**2. Communication:** In addition to assignments, lectures and individual discussions are utilized to facilitate and assess communication. Critiques (Oral), Masterwork (written & verbal), Lectures (aural-listening)

**3. Teamwork:** Students coming together to form a consensus of ideas or a common goals/assignments are achieved through the peer review project where students assess one another in a flipped classroom scenario.

**4. Social Responsible:** Every student is required to participate in the "Art in the Neighborhood" project. This project brings to light the artwork within the local community, sharing that information written and verbally through an online community tour.

## **Core Curriculum Assessment Statement**

Students will work in teams to explore and analyze a given topic that deals with how an aspect of visual art and social responsibility relate. Student teams will then create a written, oral and visual project that effectively communicates the given topic. The responsibility of each team member is to research and analyze the gathered material and contribute to the creation of the resulting project that outlines their findings, analysis and interpretation.

## **Course Purpose**

This course presents a survey of the visual arts, including artistic media and techniques, and art history. Students in Art Appreciation will also explore visual principles and elements through hands-on activities.

## **Description of Course Content**

This course is intended to be a broadly based introduction to the visual arts and will deal with issues such as the nature of art, the content and meaning of art, the artists' means of production and, finally, the development of art over time. Students in Art Appreciation will learn to consider ideas, concepts, social, cultural, economic, and other factors when analyzing specific art works and will learn to apply these factors when creating objects.

## **Objectives and Requirements**

By the end of the semester the student who passes with a final grade of "C" or above will have demonstrated the ability to: Complete and comprehend all graded assignments. Attend class regularly, missing no more than 12.5% of instruction (12 hours). Arrive at class promptly and with the required materials for that day's session.

Be prepared for and participate in small group or class discussions. Demonstrate the ability to communicate orally in clear, coherent, and persuasive language. Demonstrate the ability to use computer-based technology in communicating, solving

- Compare and contrast works of art from the text using the terminology and iconography of art.
- Explain the function of art in its historical context.
- Complete the required studio art assignments which will constitute approximately 25% of the final grade.

## Modules

Complete at least 1 module per week, 8 total. Each module should be viewed in sequence. Each module has a set date and complete it must be completed. If it is not completed at all or fully the graded activities not completed will be counted against your grade.

View the module in its entirety. The information, you are responsible for, is contained in each module. It is highly recommended to read and view the entire module before completing the assignment. However, you may skip directly to the assignment, or other graded activity. The graded activity is based in the module's information, not knowing this information will more than likely result in a low score. Any negative, nasty, mean-spirited, vulgar or offensive messages or answers will absolutely result in a lower grade.

Never, whether test/assignment or other, make me hunt for your answer, I will not take the time to "find your answer". When answering make your answers legible, concise yet full, intelligible and easy to ascertain.

For each assignment You have 1 opportunity to submit your answers. Any comments made by the instructor are for future use, not to change previous answers.

All online assignments should be written in a full and professional manner. While grammar in itself will not be graded, proper grammar skills should be on display at all times. Never should any crude, foul or offensive wordings be used. The instructor has the sole discretion to determine a lower score if should practices as grammar skills are not utilized and improper language is.

- Complete the module prior to due date, if you run into issues you can send the instructor a message to his inbox, that a problem has occurred.
- Images are required with a number of assignments, learn how to do so before it becomes an issue. There are several online demonstration videos, including youtube.com
- Issues must be brought to the instructor's attention at least 24hours prior to due date to avoid point deductions.
- No emails, correspondences or answers should ever be rude, crass, argumentative, aggressive or offensive in nature. Points deduction will occur based on the severity of tone.

## **Tests/Quizzes**

Tests and the Final exam will be assessed during the semester. Each test will be a variety of multiple choice and fill-in the blank/short answer questions. And will be based on the online information provided.

You may use your notes for the tests/quizzes/exams. However, each tests/quizzes/exams is timed and you may not have enough time to research every

question. So you are required to do your due diligence in studying and preparing for the test as you normally would in a face-to-face meeting.

All tests/quizzes/exams will be online, UNLESS serious improprieties occur. While you can use your notes, NO other helps can be utilized including but not limited to:

Fellow student, Fellow classmate outside assistance of any kind

If such improprieties are suspected the entire class will be required to take all remaining tests/quizzes/exams and the Final exam at an on campus monitored location, with no use of notes. If this eventuality occurs specific instructions will be given at the appropriate time.

The online tests/quizzes/exams will have a set time period (number of days) to complete the test and time (60min usually) to complete the test. Failure to do so and the student will not get another opportunity to take the quiz.

tests/quizzes/exams are timed (60min usually) and will probably take most of that time, be sure to have set aside a full hour of your personal time prior to starting. Once the clock starts it continues to run until the time runs out. If you run out before finishing the remaining uncompleted portion of the tests/quizzes/exam will count against your grade. This is also the case for days allowed, you have a set number of days (roughly 1 week) to complete. There are NO retakes, do-overs or extended time to take test. There is a set time and set date in which to complete the tests/quizzes/exam. Those sets are not immutable.

if a student misses a tests/quizzes/exam for any reason even if under the allowable allotment, the student will recieve a zero for the test as there will be no retake or make-up.

Cheating in any form will not be tolerated. if the Instructor SUSPECTS cheating you will automatically be awarded a Zero for the assignment/test/exam. If the student is caught, the student will receive a Zero for the entire semester/course and be submitted to academic conduct control personnel.

All students must keep their tests covered at all times, allowing another student to look at your test makes you complicit in cheating and will result in a Zero grade on the test, and subject to Academic Misconduct referral. Tests/Final all student are given a pack of papers with the test questions and the student is to answer directly on the handout.

No answers should be written on the exams/tests or papers which taunt or mock the Instructor or the class. Also, no answer should be given that is vulgar or offensive in any way. Each offense will be a 10pt deduction PLUS one point per letter of the offensive term/answer. If the offense is deemed (upon the complete determination of the instructor of this class) the penalty will be a ZERO for the tests/quizzes/exam/paper that the offense occurred. If the offense occurs a second time on the same tests/quizzes/exam/paper the second offense will incur an automatic Zero on the

test/paper. If the student chooses to do the same offense on a succeeding tests/quizzes/exam/paper the student WILL receive a zero for a final grade.

### Take Home Test (Final Review)

The Out-of-Class Assignment is 50 questions, comprising Fill-in questions and essay questions. 25 questions based on a work of art the student responds to favorably. 25 questions based on a work the student responds to unfavorably. The assignment is worth 200 points.
