Course Description:

This course is a global investigation of the styles and methods of artistic production covering Prehistoric through Gothic periods. Media studied include: drawing,

painting, sculpture, architecture, printmaking, textiles, ceramics, and metal arts. Using this framework, universal themes are studied within their historical, political, economic, theological, sociological, and ethnic contexts.

A chronological analysis of the historical and cultural contexts of the visual arts from prehistoric times to the 14th century. (ACGM, 2016)

Core Curriculum Objectives:

Critical Thinking Skills

[HCC: to include creative thinking, innovation, inquiry and analysis, synthesis of information]

Art history is an investigation and analysis of the styles and modes of artistic production from prehistoric times to our own. Through the study of artistic media, universal themes are explored, and students will develop an appreciation for the creative process as one that represents an evolving synthesis of cultural, personal, and technological influences. Assessment of critical thinking in course work will count for no less than 10% of the final grade.

Communication Skills

[HCC: to include effective development, interpretation and expression of ideas through written, oral, and visual communication]

Art History students will learn to interpret the language of visual communication through the study of selected artworks. Students will demonstrate effective writing skills as they fulfill instructor specific writing assignments. In addition, students will develop verbal communication skills as they participate in discussions and presentations throughout the semester. Assessment of verbal and written communication in course work will count for no less than 10% of the final grade and may be combined with other core assignments.

Teamwork

[HCC: to include the ability to consider different points of view and to work effectively with others to support a shared purpose or goal] In Art History courses we use discussion, group assignments and projects to analyze artistic production within various cultures and time periods. This exploration of culture through art allows students to connect with a variety of viewpoints and then exchange viewpoints with others. Each semester students will participate in at least one collaborative assignment designed to expand their experience in developing skills essential to working effectively with others to support a shared purpose or goal. Assessment of teamwork activities and assignments will count for no less than 10% of the final grade and may be combined with other core assignments.

Social Responsibility

[HCC: to include intercultural competency, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities] By its very nature Art History is intercultural. As a subject it explores various historical, political, economic, theological, sociological, and ethnic contexts. Using this framework, students consider the community's responsibility in such issues as art destruction/defacement and restoration, art acquisition and public display, public funding of art and censorship. Students observe current events and how they

influence or change art history, as new discoveries may change our perception about art. Students make use of the local art community (including museums, galleries, etc.) to augment their knowledge of and participation in their community. Assessment of social responsibility activities and assignments will count for no less than 10% of the final grade and may be combined with other core assignments.

Core Curriculum Assessment

Students will work in teams to explore and analyze a given topic that deals with how an aspect of visual art and social responsibility relate. Student teams will then create a written, oral, and visual project that effectively communicates the given topic. The responsibility of each team member is to research and analyze the gathered material, and contribute to the creation of the resulting project. Each team is responsible for submitting a written, oral, and visual project that outlines their findings, analysis, and interpretation of the material.

Instructional Methods

Methods of instruction may include: lecture, media/video/film presentations, media and technique demonstration, readings (from textbooks, peer-reviewed articles, books and original source seminal texts), field trips, discussions and critiques.

Student Assignments

Assignments/Activities may include: group and/or individual projects; verbal critiques; exams and/or quizzes; field trips; various assigned readings from textbooks, peer-reviewed articles, books, original source seminal texts; mandatory discussions based on various topics related to the major time periods of study in art history; writing papers including critiques, essays, analyses, reviews, research, comparing and contrasting art historical perspectives; service learning projects; and presentations. This course requires a minimum of 2,000 works in a combination of writing assignments and/or projects.

Student Assessment(s)

Methods of Assessment/Evaluation may include: projects, tests and quizzes which may include: definitions, matching, multiple choice, true/false, short answer, essay, lists; writing assignments, discussions and/or critiques; written papers including critiques, essays, analyses, reviews, research, comparing and contrasting art historical perspectives; service learning projects; presentations; group and/or individual projects; other methods as may be determined by individual instructors.

Instructor's Requirements (Additional instructor requirements may be placed here)

- Communicate effectively by completing a minimum of 2,000 words in writing assignments and/or projects
- Differentiate between the various materials, techniques, and processes traditionally used by artists
- Compare and contrast works of art using the terminology and iconography
 of art
- Identify stylistic characteristics of each of the various cultures and styles included in the course syllabus
- Explain the function and significance of art within its historical and cultural contexts

Additional requirements for Honors students.

<u>Honors students</u> will write an additional 2,000 words. They will complete a project or oral presentation that shows a higher level of analytical thinking and satisfies the requirement of the honors contract

IP (In Progress) is given only in certain developmental courses. The student must reenroll to receive credit. COM (Completed) is given in non-credit and continuing education courses.

FINAL GRADE OF FX: Students who stop attending class and do not withdraw themselves prior to the withdrawal deadline may either be dropped by their professor for excessive absences or be assigned the final grade of "FX" at the end of the semester. Students who stop attending classes will receive a grade of "FX", compared to an earned grade of "F" which is due to poor performance. Logging into a DE course without active participation is seen as non-attending. Please note that HCC will not disperse financial aid funding for students who have never attended class.

Students who receive financial aid but fail to attend class will be reported to the Department of Education and may have to pay back their aid. A grade of "FX" is treated exactly the same as a grade of "F" in terms of GPA, probation, suspension, and satisfactory academic progress.

To compute grade point average (GPA), divide the total grade points by the total number of semester hours attempted. The grades "IP," "COM" and "I" do not affect GPA.

Official HCC Attendance Policy:

Students are expected to attend classes regularly. Students are responsible for material covered during their absences, and it is the student's responsibility to consult with instructors for makeup assignments. Class attendance is checked daily by instructors.

Although it is the responsibility of the student to drop a course for non-attendance, the instructor has the authority to drop a student for excessive absences.

A student may be dropped from a course for absenteeism after the student has accumulated absences in excess of 12.5 percent of the hours of instruction (including lecture & laboratory time). For example:

For a 3 credit lecture class, meeting 3 hours per week (48 hours of instruction), a student may be dropped when their absence exceeds 6 hours)

For a 3 credit lecture/lab class, meeting 6 hours per week (96 hours of instruction, a student may be dropped when their absence exceeds 12 hours)

Administrative drops are at the discretion of the instructor. If you are doing poorly in the class, but you have not contacted your professor to ask for help, and you have not withdrawn by the official withdrawal date, it will result in you receiving a grade of "F" in the course

Course Withdrawals-First Time Freshmen Students-Fall 2007 and Later:

Effective 2007, section 51.907 of the Texas Education Code applies to first-time in college freshman students who enroll in a Texas public institution of higher education in the fall semester of 2007 or thereafter. High school students currently enrolled in HCC Dual Credit and Early College are waived from this requirement until they graduate from high school.

Based on this law, HCC or any other Texas Public institution of higher education may not permit students to drop after the official day of record more than six college level credit courses for unacceptable reasons during their entire undergraduate career.

Course Withdrawals:

Be sure you understand HCC policies about dropping a course. It is the student's responsibility to withdraw officially from a course and prevent an "F" from appearing on the transcript. If you feel that you cannot complete this course, you will need to withdraw from the course prior to the final date of withdrawal. View the module in its entirety. The information, you are responsible for, is contained in each module. It is highly recommended to read and view the entire module before completing the assignment. However, you may skip directly to the assignment, or other graded activity. The graded activity is based in the module's information, not knowing this information will more than likely result in a low score. Any negative, nasty, meanspirited, vulgar or offensive messages or answers will absolutely result in a lower grade.

Never, whether test/assignment or other, make me hunt for your answer, I will not take the time to "find your answer". When answering make your answers legible, concise yet full, intelligible and easy to ascertain.

For each assignment You have 1 opportunity to submit your answers. Any comments made by the instructor are for future use, not to change previous answers.

All online assignments should be written in a full and professional manner. While grammar in itself will not be graded, proper grammar skills should be on display at all times. Never should any crude, foul or offensive wordings be used. The instructor has the sole discretion to determine a lower score if should practices as grammar skills are not utilized and improper language is.

- Complete the module prior to due date, if you run into issues you can send the instructor a message to his inbox, that a problem has occurred.
- Issues must be brought to the instructor's attention at least 24hours prior to due date to avoid point deductions.
- No emails, correspondences or answers should ever be rude, crass, argumentative, aggressive or offensive in nature. Points deduction will occur based on the severity of tone.

Tests/Quizzes

Tests and the Final exam will be assessed during the semester. Each test will be a variety of multiple choice and fill-in the blank/short answer questions. And will be based on the online information provided.

You may use your notes for the tests/quizzes/exams. However, each tests/quizzes/exams is timed and you may not have enough time to research every question. So you are required to do your due diligence in studying and preparing for the test as you normally would in a face-to-face meeting.

All tests/quizzes/exams will be online, UNLESS serious improprieties occur. While you can use your notes, NO other helps can be utilized including but not limited to:

Fellow student, Fellow classmate outside assistance of any kind

If such improprieties are suspected the entire class will be required to take all remaining tests/quizzes/exams and the Final exam at an on campus monitored location, with no use of notes. If this eventuality occurs specific instructions will be given at the appropriate time.

The online tests/quizzes/exams will have a set time period (number of days) to complete the test and time (60min usually) to complete the test. Failure to do so and the student will not get another opportunity to take the quiz.

tests/quizzes/exams are timed (60min usually) and will probably take most of that time, be sure to have set aside a full hour of your personal time prior to starting. Once the clock starts it continues to run until the time runs out. If you run out before finishing the remaining uncompleted portion of the tests/quizzes/exam will count against your grade. This is also the case for days allowed, you have a set number of days (roughly 1 week) to complete. Once the Day allotment is used, the remaining uncompleted portion of the tests/quizzes/exam will count against your grade.

There are NO retakes, do-overs or extended time to take test. There is a set time and set date in which to complete the tests/quizzes/exam. Those sets are not immutable.

if a student misses a tests/quizzes/exam for any reason even if under the allowable allotment, the student will recieve a zero for the test as there will be no retake or make-up.

Cheating in any form will not be tolerated. if the Instructor SUSPECTS cheating you will automatically be awarded a Zero for the assignment/test/exam. If the student is caught, the student will receive a Zero for the entire semester/course and be submitted to academic conduct control personnel.

All students must keep their tests covered at all times, allowing another student to look at your test makes you complicit in cheating and will result in a Zero grade on the test, and subject to Academic Misconduct referral. Tests/Final all student are given a pack of papers with the test questions and the student is to answer directly on the handout.

No answers should be written on the exams/tests or papers which taunt or mock the Instructor or the class. Also, no answer should be given that is vulgar or offensive in any way. Each offense will be a 10pt deduction PLUS one point per letter of the offensive term/answer. If the offense is deemed (upon the complete determination of the instructor of this class) the penalty will be a ZERO for the tests/quizzes/exam/paper that the offense occurred. If the offense occurs a second time on the same tests/quizzes/exam/paper the second offense will incur an automatic Zero on the test/paper. If the student chooses to do the same offense on a succeeding tests/quizzes/exam/paper the student WILL receive a zero for a final grade.

Professionalism should be showcased by the student at all times.

There will be no make-up Tests or Exams

Be sure to complete at least one module per week, the last 2 assignments are designed to be 2week assignments is you do not keep up with the schedule you will decrease the amount of time you have to complete theses assignments, as they require you to search throughout your neighbor and a trip to the museum.

A deduction to the student's participation grade is permanent. No make-ups, re-dos, or extra credit are issued in regards to a missed or poorly executed assignment/quiz or exam.
