## **What's Exciting About This Course**

MUAP 2177 is an intermediate course in learning about the voice mechanism and singing. We will explore vocal technique, posture, appropriate repertoire, and prominent voice composers and performers.

Your voice teacher is more than someone who teaches you technique; please use me as your main resource for everything music-related.

### **Prerequisites and/or Co-Requisites**

MUAP 2177 requires college-level reading and writing skills. Research indicates that you are most likely to succeed if you have already taken and passed ENGL 1301. If you have enrolled in this course having satisfied these prerequisites, you have a higher chance of success than students who have not done so. Please carefully read and consider the repeater policy in the <u>HCCS Student Handbook</u>. It is STRONGLY recommended you either have taken or be currently enrolled in MUSI 1303 Fundamentals of Music, or in MUSI 1311 Music Theory I. The co-requisite for this course is MUAP 2179, Voice Studio III.

If you are a music major pursuing an AA in Music, you should also be enrolled in a Music Theory course, Sight Singing & Ear Training course, Piano Class course, an ensemble, and MUAP Private lessons and studio in the instrument in which you specialize. Please see a fulltime music instructor or your MUAP instructor for academic advising and to learn how you can finish a music degree in 2-3 years with proper guidance.

# **Course Overview**

Individual instruction in voice. Course may apply to a music degree.

## **Program Student Learning Outcomes (PSLOs)**

- 1. Keyboard Skills: The student will demonstrate mastery of scales, chords, & harmonization of melodies using varied accompaniment techniques. Students will perform selected compositions and demonstrate competence in various transpositions.
- 2. Music Theory Skills: The student will analyze and compose advanced 4 measure segments which include; harmony, melody, rhythm, and cadences.
- 3. Ear Training Skills: The student will sing and notate diatonic and chromatic intervals, chords, rhythms, and harmonic chord progressions.
- 4. Music Literature Skills: The student will be able to identify and describe the periods of music history including general style characteristics, major composers of each period, and representative works. Students will be able to critically evaluate musical works and articulate the relationship between historical events and musical styles/aesthetics.
- 5. Ensemble Performance Skills: The student will apply learned vocal/instrumental skills and techniques in an ensemble performance.
- 6. Solo Performance Skills: The student will demonstrate learned vocal/instrumental skills and techniques in a jury of 5-10 minutes of music appropriate to MUAP Semester 4 SLO's in a solo performance.

## **Course Student Learning Outcomes (CSLOs)**

Upon completion of MUAP 2177, the student will have/be able to:

- 1. Assume and maintain correct posture 80% of the time.
- 2. Utilize correct breathing techniques 80% of the time.
- 3. Use correct vowels and consonants 80% of the time.
- 4. Sing with good intonation 80% of the time.
- 5. Sing with note, rhythmic and word accuracy 80% of the time.
- 6. Sing with good tone quality and correct diction 80% of the time.
- 7. Demonstrate appropriate musical phrasing and style 80% of the time.
- 8. Demonstrate good stage presence 80% of the time.

## **Learning Objectives**

Student will use the Student Learning Outcome skills to successfully learn proper vocal technique and perform.

# **Student Success**

Expect to spend at least twice as many hours per week outside of class as you do in class studying the course content. Additional time will be required for written assignments. The assignments provided will help you use your study hours wisely. Successful completion of this course requires a combination of the following:

- Reading the textbook
- Attending class in person and/or online
- Completing assignments
- Participating in class activities

There is no short cut for success in this course; it requires reading (and probably re-reading) and studying the material using the course objectives as a guide.

# Assignments, Exams, and Activities

## Written Assignment

One concert review will be submitted by the last lesson of the semester. You will attend a live or virtual performance and review the singer's technique, language skills, expressiveness, etc.

A word-for-word and poetic translation of foreign language songs is due during week five of the semester.

#### Exams

Weekly lessons are graded, and the final exam is a virtual jury in front of HCC voice faculty. Juries will be help on Saturday, May 8th.

### **In-Class Activities**

Students will work on technique, diction, translation, expression and related topics in each lesson. Assignments given one week should be completed by the following lesson. Students are required to learn and perform a minimum of five songs per semester, at least one of them being classical, and at least one in a foreign language.

Students should know the meanings of all musical markings found in their assigned songs.

### Final Exam

The final exam is a virtual jury in front of the voice faculty on May 8th.

Students who are absent from the final exam without discussing their absence with the instructor in advance or within 24 hours afterward will receive an exam grade of "F". Students who cannot make the final exam due to health or emergency reasons will receive an "incomplete". This grade will stand until it is replaced the following semester, otherwise it will turn into an "F" the following semester.
