## **What's Exciting About This Course**

MUSI 2117 is a foundation course in understanding and enjoyment of music through the use of fundamentals of music. Elements of music and analysis of music form and how they relate to compositional technique are explored. In this course we will develop your ability to hear pitches and rhythms and notate them, as well as your listening perception through lectures, recordings, videos, and concerts. The ability to read the music notes off a page and sing the pitches and rhythms correctly will also be improved. The course will also include a discussion of the basic music elements, such as melody, rhythm, harmony, timbre, texture, form and acoustics.



### **Course Overview**

Singing advanced tonal music and introduction of modal and post-tonal melodies. Aural study including dictation of advanced rhythm, melody, and harmony. Course applies to a music major degree.

## **Program Student Learning Outcomes (PSLOs)**

- 1. Keyboard Skills: The student will demonstrate mastery of scales, chords, & harmonization of melodies using varied accompaniment techniques. Students will perform selected compositions and demonstrate competence in various transpositions.
- 2. Music Theory Skills: The student will analyze and compose advanced 4 measure segments which include; harmony, melody, rhythm, and cadences.
- 3. Ear Training Skills: The student will sing and notate diatonic and chromatic intervals, chords, rhythms, and harmonic chord progressions.
- 4. Music Literature Skills: The student will be able to identify and describe the periods of music history including general style characteristics, major composers of each period, and representative works. Students will be able to critically evaluate musical works and articulate the relationship between historical events and musical styles/aesthetics.
- 5. Ensemble Performance Skills: The student will apply learned vocal/instrumental skills and techniques in an ensemble performance.
- 6. Solo Performance Skills: The student will demonstrate learned vocal/instrumental skills and techniques in a jury of 5-10 minutes of music appropriate to MUAP Semester 4 SLOs in a solo performance.

## **Course Student Learning Outcomes (CSLOs)**

Upon completion of MUSI 2117, the student will be able to:

- 1. Apply a method of sight singing to more difficult diatonic and non-diatonic melodies, including modes and non-tonal scales.
- 2. Transcribe more complex rhythms, including contemporary materials.
- 3. Transcribe increasingly difficult chromatic melodies.
- 4. Transcribe and analyze diatonic and chromatic progressions.
- 5. Read and reproduce rhythms in various meters, including asymmetrical meters, syncopation, and irregular beat divisions.

## **Learning Objectives**

Student will use the Student Learning Outcome skills to successfully hear rhythmic, melodic, and harmonic passages and successfully notate them on a grand staff, as well as successfully sight-read complex music. This course is designed to prepare students for University level music theory and aural skills courses and exams.

### **Student Success**

Expect to spend at least twice as many hours per week outside of class as you do in class studying the course content. Additional time will be required for written assignments. The assignments provided will help you use your study hours wisely. Successful completion of this course requires a combination of the following:

- Reading the textbook
- Attending class in person and/or online
- Completing assignments
- Participating in class activities

There is no short cut for success in this course; it requires reading (and probably re-reading) and studying the material using the course objectives as a guide.

Each week we will do dictation and sight singing activities in class, some of which will be graded.

#### **Final Exam**

Our final exam will be on Thursday, May 13th at Noon.

Students who are absent from the final exam without discussing their absence with the instructor in advance or within 24 hours afterward will receive an exam grade of "F". Students who cannot make the final exam due to health or emergency reasons will receive an "incomplete". This grade will stand until it is replaced the following semester, otherwise it will turn into an "F" the following semester.
