A.14 Course Description	PSYC 2301 is a survey course of the basic principles underlying human behavior. Emphasis is placed on major areas of study in the field of psychology, such as motivation, development, thought processes, personality.
A.15 Prerequisites	PSYC 2301 requires college-level reading and writing skills. Research indicates that you are most likely to succeed if you have already taken and passed ENGL 1301. The minimum requirements for enrollment in PSYC 2301 include placement in college-level reading (or take INRW 0420 or ESOL 0360 as a co-requisite). If you have enrolled in this course without having satisfied these prerequisites, you are at higher risk of failure or withdrawal than students who have done so, and you should carefully read and consider the repeater policy in the hCCStudent-Handbook .

Instructions for Written Assignment—Research Article Summary

Go to PsycPORT http://www.apa.org/news/psycport/ and select a research article related to one of the following topics: stress, personality, psychological disorders, therapies, research ethics, brain function, biology and behavior, learning, memory, human development.

- 1. You must choose an article that describes *research* used (you will be graded on this).
- 2. Your summary must be 200 words.
- 3. Your paper must include 1) the main ideas of the article (200 words), 2) brief descriptions of research cited in the article--such as demographics and methodology, and 3) a link to the article.
- 4. The format must be as follows:
 - 1. Summary (must be 200 or more words)

Write your content... 2. Brief Description of Research Cited Write your content... 3. Link to Article Include your link so that I can click on it 4. No direct quotes or copied/pasted text from the article are allowed. 5. Proper English including punctuation, spelling and grammar is expected.
