<u>COURSE DESCRIPTION</u>: This is a university-equivalent, college sophomore "*Principles*" course in Economics. The content of the curriculum will focus on the following "*microeconomic*" concepts:

- √ Market supply and demand analysis, elasticity, consumer behavior
- √ Pure Competition, Monopoly, Oligopoly, and Monopolistic Competition
- √ Cost and revenue analysis/profit maximization schemes
- √ Resource demand
- √ Antitrust analysis
- √ Capital and Land Markets
- √ Labor market theory and wage determination.
- √ Income distribution
- √ International trade

- 4) Access and use the available PowerPoint documents in **CONNECT**
- 5) Access and refer to Chapter Learning Objectives in **CONNECT**
- 6) Access and view any available videos and YouTube clips
- 7) From the **CONNECT** Library Menu access and complete all Self Quizzes

ALL tests and the final exam are administered online on the *CONNECT* platform. See the course calendar below for test dates, times, and chapters covered on each test.

FINAL COURSE GRADE DETERMINATION:

Three (3) tests and a final examination each are worth 25% of your final grade. Each of the three tests and the final exam will include multiple-choice questions (100%).

Completion of all of the **CONNECT** chapter exercises, assignments, and related activity are extremely important to your successful completion of the course. However, only your test and final exam scores will be used to calculate your final grade in the course.

GRADE SCALE: After all tests your semester numerical average will be applied to the following grade scale to determine your final letter grade (NO EXCEPTIONS):

Numerical average above 89.5 = "A" Numerical average between 79.5 and 89.4 = "B" Numerical average between 69.5 and 79.4 = "C" Numerical average between 59.5 and 69.4 = "D" Numerical average below 59.5 = "F"

MISSED TEST POLICY:

All tests and the final exam are to be administered online during time sensitive "windows" throughout the semester.

The <u>first time</u> you miss a test for whatever reason, a score of "0" will be entered in your grade book for the missed test.

The second time you miss a test for whatever reason, a final grade of "FX" will be assigned to you at the end of the semester.

If you miss the final exam for whatever reason or circumstance and the final exam is the second test you have missed, a final grade of "FX" will be assigned to you at the end of the semester.
