Course Description

HIST 1302 is a survey of the social, political, economic, cultural, and intellectual history of the United States from the Civil War/Reconstruction era to the present. United States History II examines industrialization, immigration, world wars, the Great Depression, Cold War and post-Cold War eras. Themes that may be addressed in United States History II include: American culture, religion, civil and human rights, technological change, economic change, immigration and migration, urbanization and suburbanization, the expansion of the federal government, and the study of U.S. foreign policy.

Essay	200 points	Historical Fiction	<p>Historical fiction is defined as movies and novels in which a story is made up but is set in the past and borrows true characteristics of the time period in which it is set^[1]. In other words, it is fiction (make believe) that is set, uses, compares, or takes place in history.</p> <p>Some well-known examples of historical fiction include: <i>Gone With the Wind</i>, <i>To Kill a Mockingbird</i>, <i>The Three Musketeers</i>, and <i>The Hunchback of Notre Dame</i>. By the assignment due-date you will write your own short piece of historical fiction (fully cited in MLA, APA, or Chicago style).</p> <p>The minimum requirements for the essay include: 6+ pages minimum, full citation of sources in the paper (a Works Cited is not good enough), proof-read and largely free of grammatical errors. You will be graded on the quality and originality of the work. While many students may wish to just write a paper, this assignment may also be completed as a presentation. If you choose to do a presentation you may pick the medium (e.g. video, animation, etc.). Please discuss your presentation with me before you begin so I can make sure we are on the same page, so to speak. The Historical Fiction is worth 200 points.</p> <p>[1] "historical-fiction." Essay	200 points-	Argumentative Essay	At the end of Unit 2 you will submit a 3-5+ page essay arguing your perspective and opinion on an event in US History. There will be a choice of topics and you will be graded on the strength of your arguments, the quality of your sourcework, and the persuasiveness of your essay.
Essay/Quiz	200 points	Monograph Analysis	An assignment analyzing our monograph, <i>Isaac's Storm</i> . The analysis has two parts: 4 quizzes and an essay. The quizzes make-up 50 points and the essay comprises the remaining 150 for a total of 200 points.
Discussions	200 points total	Discussion 1, Discussion 2, Discussion 3, and Issac's Storm Discussion	At the end of each unit I will post a short discussion question covering the Unit material. These questions are generally argumentative. Your response will be posted on the Discussion Board. The responses need to be informative and clear, but not necessarily long; two or three paragraphs should suffice. After posting your response you will have to comment on a fellow student's response (except for the <i>Isaac's Storm</i> Discussion). Your comments must be informative, argumentative, and/or amend the response. In other words, a simple 'I agree' or 'I disagree,' is not good enough. Each Discussion is worth 50 for a total of 200 points.

You must read the assigned text and watch the accompanying video. After you are well-versed in the material, you need to take a short quiz. I am far more lenient when I know there is a problem ahead of time. If you contact me after an assignment is due, you will most likely not get an extension or you will be granted an extension with a large point deduction.
