## **Course Description:**

This course is a study of the major issues in philosophy and/or the work of major philosophical figures in philosophy. Topics in philosophy may include theories of reality, theories of knowledge, theories of value, and their practical applications (Texas ACGM). It provides a theoretically diverse introduction to the study of ideas, including arguments and investigations about abstract and real phenomena, particularly in the areas of knowledge, ethics, and religion (HCC Course Catalogue). This course stresses the HCC Core Objectives of Critical Thinking, Communication Skills, Personal Responsibility, and Social Responsibility.

#### **Grading Components and Weights:**

**One Essays 2-4 pages long;** MLA format; double spaced; with a work cited page at the end of the essay using the text as the primary source and at least one external source other than *Sparknotes* or *Cliffnotes*; 100 points each for a total of 100 points

One Presentation 5-10 minutes with a visual aid (such as PowerPoint, Prezi, or handout) 100 points each

Three exams worth 100 points each.

Short Writings (in class) count for a total of 100 points (variable number)

Extra credit (reviews) variable points

Essays: **Each student will complete one- two to four page essay**. The essays satisfy the intellectual competencies of reading, writing, critical thinking, and computer literacy. Essays should be in standard MLA format and should be carefully proofread and free from errors. Students who plagiarize on essays will receive a 0 for that assignment or a grade at the discretion of the professor. If a student plagiarizes twice on separate assignments then the student will receive an "F" in the course. Plagiarism is the intentional or negligent copying or paraphrasing of sources without proper citation. Essays are assigned according to topics. Topics are given in the Learning Web for the course. Students are required to write on **only one** of the topics assigned. Essays count for 100 points each. Essays are typically graded within one week of due date. Emailed essays receive a one grade deduction and subsequent deductions after 12 hours of lateness.

Presentation: Each student will provide a 5-10 presentation to the class using a visual aid such as a Powerpoint, Prezi or Handout presentation. All presentations should have five to ten slides should include a works cited page and should have suitable, appropriate and relevant images, such as images of the philosopher presented on. Presentations are assigned by last name. The first presentation on presentation/ essay one topics will be assigned roughly half way through the class to those students whose last name begins with the letters A-M. The second presentation on presentation two topics will be assigned towards the end of the semester to those students whose last name begins with the letters N-Z. There are no make-ups for presentations. This means that if you miss your presentation time there will not be an alternate time for you to make it up.

#### **Grading Policy:**

All grades will be calculated according to a percentage of *total points*. The total number of points for this term is 600. The term grade legend follows:

A = 90% to 100% (600 to 540 point)	4 points per semester hour
B = 80% to 89.9% (539 to 480 points)	3 points per semester hour
C = 70% to 79.9% (479-420 points)	2 points per semester hour
D = 60% to 69.9% (419- 360 points)	1 point per semester hour
F = 0% to 59.9% (000 to 359 points)	0 points per semester hour
FX (Failure due to non-attendance)	0 points per semester hour
IP (In Progress)	0 points per semester hour
W (Withdrawn)	0 points per semester hour
I (Incomplete)	0 points per semester hour
AUD (Audit)	0 points per semester hour

IP (In Progress) is given only in certain developmental courses. The student must re-enroll to receive credit. COM (Completed) is given in non-credit and continuing education courses. FINAL GRADE OF FX: Students who stop attending class and do not withdraw themselves prior to the withdrawal deadline may either be dropped by their professor for excessive absences or

be assigned the final grade of "FX" at the end of the semester. Students who stop attending classes will receive a grade of "FX", compared to an earned grade of "F" which is due to poor performance. Logging into a DE course without active participation is seen as non-attending. Please note that HCC will not disperse financial aid funding for students who have never attended class.

Students who receive financial aid but fail to attend class will be reported to the Department of Education and may have to pay back their aid. A grade of "FX" is treated exactly the same as a grade of "F" in terms of GPA, probation, suspension, and satisfactory academic progress. To compute grade point average (GPA), divide the total grade points by the total number of semester hours attempted. The grades "IP," "COM" and "I" do not affect GPA.

#### **Late Policy:**

Late essays. Essays will be marked down 10 points every calendar day they are late starting after 12 hours of lateness. It is the student's responsibility to verify that their essay was submitted in class correctly and fully. Incorrect essays submitted or blank essays submitted which require the resubmission of essays will incur the above late penalty. Essays and late work will not be accepted after the last day of class unless prior arrangements have been made with the instructor. Emailed essays receive a one grade deduction in addition to any late deduction. Plagiarized essays may not be returned but may be held for instructor's records.

### **Make-up Policy:**

Make ups are available only with a documented excuse of a serious nature or by prior arrangement. No late assignments are allowed after the final day of class unless prior arrangements have been made with the instructor. See calendar for final date.

**Late essays. Essays will be marked down 10 points every calendar day they are late after 12 hours.** Essays and late work will not be accepted after the last day of class unless prior arrangements have been made with the instructor. Essays receive a one grade deduction for being emailed in addition to any deduction for being late.

In class writings must be completed in class on the day assigned and may not be made up.

There are no make-ups for presentations.

## **Attendance and Withdrawal Policy:**

HCC Students are expected to attend class regularly. A daily record of absences may be maintained throughout the semester. NOTE: It is the responsibility of the student to drop, or officially withdraw from this course. Your instructor will withdraw a student if and only if provided a written request from that student within the time limits set by the academic course calendar. Additionally, system-wide rules affect withdrawals:

- (1) Students who repeat a course for a third, or more times, may face a significant tuition/fee increase at HCC and other Texas public colleges and universities.
- (2) The Texas Legislature passed a law limiting new students (those starting college in Fall 2007) to no more than six total course withdrawals throughout their academic career in obtaining a baccalaureate degree. There may be future penalties imposed.
- (3) No student may withdraw from a course following the set "last date to withdraw", which varies by course (For details see the academic calendar: http://www.hccs.edu/district/events-calendar/academic-calendar/). In this class the last day to withdraw for this class is 4/01/2019. After that date and time, a student can only be given a grade earned, or an "I" for incomplete. Incompletes must be made up by the end of the following long semester, after which they will automatically change to a grade of "F". Students receiving an "I" for a course are ineligible for graduation until the "I' has been removed from a student's transcript.
