Course Description:

This is a systemic evaluation of classical and/or contemporary ethical theories concerning the good life, human conduct in society, morals, and standards of value (Texas ACGM). This course provides a practical, community-minded introduction to questions of character and human excellence in a multi-cultural, global environment. Traditional and contemporary views concerning the nature of goodness, happiness, duty, and freedom serve as points of departure for this largely thematic inquiry into right conduct and ways of thinking that leads to that conduct (HCC Catalogue). This course stresses the HCC CORE Objectives of Critical Thinking, Communication, Social Responsibility, and Personal Responsibility.

Grading Components and Weights [Selected by Instructor]:

Assessment:

There are 2 3-4 page **papers**. (100 points: A+ counts as 100) Each paper should make reference to the text[s] in the MLA format (<http://owl.english.purdue.edu/owl/resource/557/01/>). Each paper should be a discussion of one of the assigned themes or topics announced (or some other relevant topic with prior approval from the instructor). All students who struggle with composition are encouraged to attend Central College's Writing Center (http://ccollege.hccs.edu/instru/english/writing_center_lab.htm). This class is not a class in composition but presupposes that students understand the basics of grammar and composition. Late essays are marked down one grade letter for every calendar day late.

There are three tests (50 points each)(not including the final). Each test consists of true false and multiple-choice questions. **Make up tests are available only with prior approval**. This means if you miss the test and haven't already cleared your absence with me in advance you will earn a "0" on the test and will not be able to make it up. The last test is the final exam which is comprehensive.

There is a final exam, which is worth 100 points and is cumulative.

There are discussion questions, which are worth 100 points total. **All discussions must be finished by the time the quiz on the material covered ends. Late discussions will not receive credit.** Extra credit student led discussions can be completed for extra credit. Extra credit discussions also must be completed by the time the quiz on the material closes.

Grading Policy [Example]:

All grades will be calculated according to a percentage of *total points*. The total number of points for this term is 550. The term grade legend follows:

A = 90% to 100% (550 to 495 points)	4 points per semester hour
B = 80% to 89.9% (494 to 440 points)	3 points per semester hour
C = 70% to 79.9% (439 to 385 points)	2 points per semester hour
D = 60% to 69.9% (384 to 330 points)	1 point per semester hour
F = 0% to 59.9% (000 to 329 points)	0 points per semester hour
FX (Failure due to non-attendance)	0 points per semester hour
IP (In Progress)	0 points per semester hour
W (Withdrawn)	0 points per semester hour
I (Incomplete)	0 points per semester hour
AUD (Audit)	0 points per semester hour

IP (In Progress) is given only in certain developmental courses. The student must re-enroll to receive credit. COM (Completed) is given in non-credit and continuing education courses.

FINAL GRADE OF FX: Students who stop attending class and do not withdraw themselves prior to the withdrawal deadline may either be dropped by their professor for excessive absences or be assigned the final grade of "FX" at the end of the semester. Students who stop attending classes will receive a grade of "FX", compared to an earned grade of "F" which is due to poor performance. Logging into a DE course without active participation is seen as non-attending. Please note that HCC will not disperse financial aid funding for students who have never attended class.

Students who receive financial aid but fail to attend class will be reported to the Department of Education and may have to pay back their aid. A grade of "FX" is treated exactly the same as a grade of "F" in terms of GPA, probation, suspension, and satisfactory academic progress.

To compute grade point average (GPA), divide the total grade points by the total number of semester hours attempted. The grades "IP," "COM" and "I" do not affect GPA.

Late policy:

Late essays. Essays will be marked down 10 points every calendar day they are late. However, essays and late work will not be accepted after the last day of class unless with prior arrangements and at the discretion of the instructor. Students are responsible for ensuring that their submitted assignments are in a readable file format and submitted on time. Students who submit essays that are in an unreadable format or not fully submitted may receive a late points deduction at the discretion of the instructor. All emailed essays receive a one grade deduction in addition to any late deduction. This also applies to essays that are submitted as unreadable or corrupted files.

Make-ups are available only with a documented excuse of a serious nature. No late assignments are allowed after the final day of class at the discretion of the instructor. See calendar for final date.

However, essays and late work will not be accepted after the last day of class except at the instructor's discretion and with prior arrangement. All emailed essays receive a one grade deduction in addition to any late deduction.

Attendance and Withdrawal Policy:

HCC Students are expected to attend class regularly. A daily record of absences may be maintained throughout the semester. NOTE: It is the responsibility of the student to drop, or officially withdraw from this course. Your instructor will withdraw a student if and only if

provided a written request from that student. Additionally, system-wide rules affect withdrawals:

- (1) Students who repeat a course for a third, or more times, may face a significant tuition/fee increase at HCC and other Texas public colleges and universities.
- (2) The Texas Legislature passed a law limiting new students (those starting college in Fall 2007) to no more than six total course withdrawals throughout their academic career in obtaining a baccalaureate degree. There may be future penalties imposed.
- (3) No student may withdraw from a course following the set "last date to withdraw", which varies by course and semester (For details see the academic calendar: <http://www.hccs.edu/district/events-calendar/academic-calendar/>). After that date and time, a student can only be given a grade earned, or an "I" for incomplete. Incompletes must be made up by the end of the following long semester, after which they will automatically change to a grade of "F". Students receiving an "I" for a course are ineligible for graduation until the "I" has been removed from a student's transcript.
