
# **Canvas Learning Management System**



### **Course Overview**

<u>ECON 2302 – Principles of Microeconomics</u> presents an analysis of the behavior of individual economic agents, including consumer behavior and demand, producer behavior and supply, price and output decisions by firms under various market structures, factor markets, market failures, and international trade. This is a core curriculum course.

# **Core Curriculum Objectives (CCOs)**

ECON 2302 satisfies the social science requirement in the HCCS core curriculum and addresses the following core objectives which will be evaluated in this course through exams, homework assignments or written work.

- 1. <u>Critical Thinking Skills</u> (CT): To include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information.
- 2. <u>Communication Skills</u> (COM): To include effective development, interpretation and expression of ideas through written, oral and visual communication.
- 3. <u>Empirical and Quantitative Skills</u> (EQS): To include the manipulation and analysis of numerical data or observable facts resulting in informed conclusions.
- 4. <u>Social Responsibility</u> (SR): To include intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national and global communities.

Course Student Learning Outcomes (CSLOs)

Upon completion of ECON 2302, the student will be able to:

- 1. Explain the role of scarcity, specialization, opportunity cost and cost/benefit analysis in economic decision-making.
- 2. Identify the determinants of supply and demand; demonstrate the impact of shifts in both market supply and demand curves on equilibrium price and output.
- 3. Summarize the law of diminishing marginal utility; describe the process of utility maximization
- 4. Calculate supply and demand elasticities, identify the determinants of price elasticity of demand and supply, and demonstrate the relationship between elasticity and total revenue.
- 5. Describe the production function and the Law of Diminishing Marginal Productivity; calculate and graph short-run and long-run costs of production
- 6. Identify the four market structures by characteristics; calculate and graph the profit maximizing price and quantity in the output markets by use of marginal analysis.
- 7. Determine the profit maximizing price and quantity of resources in factor markets under perfect and imperfect competition by use of marginal analysis
- 8. Describe governmental efforts to address market failure such as monopoly power, externalities, and public goods
- 9. Identify the benefits of free trade using the concept of comparative advantage.

# Assignments, Exams, and Activities

#### **Exams**

**Exams description:** There will be four unit exams and a comprehensive final. Each unit exam will be worth 15% of your final grade, and the final exam will be worth 20% of your final grade. See the schedule for the exam dates. Unit 1 covers chapters 1-3 only; Unit 2 covers chapters 4-7 only; Unit 3 covers chapters 8-12; and Unit 4 covers chapters 13-16, 32 The lowest exam grade will be dropped. If you miss an exam that will be the dropped exam. There are no make-up exams. All exams will be in canvas.

**Inquizitive -** All students will be required to do homework assignments in Inquizitive. Inquizitive is an online learning software that will allow you to work problems and test your understanding of the course topics. In all there will be 16 assignments. The grades from the best 13 assignments will be averaged together to determine the homework component of your overall course grade (25%). You may continue to improve your score by working on each assignment until the due date. The due dates are listed on the course schedule page. You must access these through Canvas. YOU MUST PAY FOR INOUIZITIVE.

Participation: There will be weekly discussion boards to complete in Canvas. This will count for 15% of your final grade. One discussion assignment will be dropped. Discussions will be due on Saturday.

#### Final Exam

**Final exams description:** The final is comprehensive and covers all chapters. Taken on Canvas.

Weight of final exam: 15%

# Make up policy for final exam:

If students miss the final exam, it is their responsibility to contact their instructor within 24 hours via email and arrange a make up at the discretion of the instructor. The student must be assigned a course grade by the institutional deadline.

### **Attendance Procedures**

If a student does not attend class by the Official Day of Record, they will be dropped automatically for non attendance.

For online students, participation (as defined by your instructor) is necessary to show attendance.

Class attendance is monitored daily. Although it is your responsibility to drop a course, the instructor has the authority to drop students for excessive absences. You may be dropped from a course after accumulating absences in excess of 12.5 percent of the total hours of instruction (lecture and lab). For example: For a 3 credit-hour lecture class meeting 3 hours per week (48 hours of instruction), you can be dropped after 6 hours of absence. Administrative drops are at the discretion of the instructor.

Failure to withdraw officially can result in a grade of "F" (or "Fx" if you stop attending classes or logging in and completing assigned work for online classes) in the course.
