Prerequisite: A satisfactory assessment score.

Course Description: ENGL 1302, Composition II, is a more extensive study of the skills introduced in English 1301 with an emphasis on critical thinking, research and documentation techniques, and literary and rhetorical analysis.

Student Learning Outcomes: A student who successfully completes English 1302 will be able to:

- demonstrate the ability to use the writing process consistently and effectively for both in-class and out-of-class essays (thus reinforcing English 1301 instruction);
- understand and apply the basic principles of critical thinking—evaluation, analysis and synthesis—as they write essays that persuade or argue;
- be able to analyze, in writing, readings by professional and student writers for such elements as purpose, audience, tone, style, writing strategy, and for much deeper meaning;
- be able to develop a critical and creative essay in response to an issue related to reading(s) or other class projects;
- demonstrate the ability to resist simplistic formulations, whether in their own or others' texts;
- understand the characteristics of imaginative texts and write effective analyses of various genres;
- be able to acknowledge, as appropriate, their own history, interests, and biases as they discuss a topic, thus placing themselves credibly in discussion;
- develop the ability to research and write a documented paper;
- make effective stylistic choices (diction, tone, sentence structure) in all writing assignments, depending upon audience and purpose of a piece of writing;
- apply suggestions, as appropriate, from evaluated compositions to other writing tasks;
- fulfill the writing requirements of at least 6000 words during the semester; and
- apply basic principles of rhetorical analysis
- write essays that classify, explain, and evaluate rhetorical and literary strategies employed in argument, persuasion, and various forms of literature;
- identify, differentiate, integrate, and synthesize research materials into argumentative and/or analytical essays;
- employ appropriate documentation style and format across the spectrum of in-class and out-of-class written discourse;
- demonstrate library literacy. (HCC Student Learning Outcomes)

Methodology: This course is a writing workshop during which rough drafts, peer editing, writing conferences, and class discussions will occur.

Materials:

- Any kind of journal or notebook for keeping personal reflections, brainstorming, etc.
- Loose-leaf paper
- Black or blue pens
- Electronic device (optional)
- Required books (listed below)

Class Practices and Procedures

1. Attendance: College policy stipulates that any student who misses more than 12.5 % of instruction may be subject to administrative withdrawal. As a result, any student who misses more than 12.5% of the class will be dropped from the class. Attendance and on time arrival to class are essential to your class success. - **2. Assignments**: All papers assigned to be completed outside of class are due at the beginning of the class period on the assigned due date. Papers must be uploaded to the SPX class website AND uploaded to Turnitin.com before the due date (email and data storage devices will not be accepted, so do not ask). If essays are not submitted to BOTH locations a grade will not be given; failure to complete both aspects of the submission requirements will result in a permanent zero being entered for the assignment. Remember: final draft of papers will be uploaded electronically. Portfolio hard copies will be submitted in class.
- 3. **Late Work/ Make-up work**: All out of class papers are due at the start of class on the date designated. I <u>DO NOT</u> accept late work. If you miss a day of class, you are responsible for checking the website and making up what you missed. Arrange to contact a classmate to find out what you may have missed in class. There will be no make-up of Final Examination unless you make prior arrangements with me with a valid excuse for your absence.
- 4. **Electronic Devices:** The use of cell phones in class causes disruption and loss of instructional time. If your phone is out it will be confiscated. Laptops may be used (only with permission) unless they are deemed a disruption to the class or are being used for something other than to take notes. Students with appropriate accommodations may use laptops with permission.
- 5. **Tutoring**: I will hold tutorials every Monday from 11:30 am to 12:30 pm unless otherwise posted on my website. I will also hold tutorials by appointment.
- 6. **Tardiness**: Please arrive on time. I will take attendance every day at the beginning of class.
- 7. **Participation**: Your level of participation in class discussions and evidence of your preparation for these discussions are important to your final grade and to enhancing your ability to analyze literary works.
- 8. School Rules: All St. Pius X rules must be followed, and college-level maturity is expected.
- 9. **One Last Thought**: This is a college course. As such, you will be treated like college students. Moreover, you will be graded like college students. You are expected to demonstrate maturity and self-control. You are expected to take your work seriously. You are expected to budget your time wisely to complete all work by its due date.
