**Course Description: ACGM or WECM**

Through a combination of lecture, hands-on exercises, home works assignments, drawing problems and examinations, this course introduces the student to computer-aided design/drafting with the AutoCAD software. The AutoCAD topics covered in this course include an introduction to AutoCAD features, starting and setting up drawings, point coordinate entry methods, creation of 2D objects, layer management, line types and colors, selection sets, object snap modes, editing geometry, display control and drawing inquiry methods.

**Course Objectives**

After completing this course, the student will be able to do the following:

1. Use AutoCAD's precision drawing tools and methods to construct accurate 2D drawings.
2. Create and manage drawing layers, and control object colors and line types
3. Create, edit and modify text styles and text objects in AutoCAD.
4. Control the drawing display and utilize named drawing views.
5. Construct and edit polylines, multilines and splines.
6. Creating shapes and symbols
7. Special editing operations that increase productivity
8. Drawing geometric shapes and constructions.

## **Academic Honesty**

Students are responsible for conducting themselves with honor and integrity in fulfilling course requirements. A student who submits the work of another student as her/his own deliberately fails to properly credit words or ideas borrow from another source is guilty of plagiarism. A student who takes an exam for another student, copies answer from another student's exam, copies drawings in any manner, or engages in any other similar conduct aimed at making false representation with respect to student's academic performance is guilty of cheating. Disciplinary proceedings may be initiated by the college system against a student accused of scholastic dishonesty. Penalties can include a grade of 'O' or 'F' on the particular assignment, failure in the course, academic probation or even dismissal from the college. ## **Administrative and Student Withdrawals**

For 16 week Spring '15 classes, this date is **March 24<sup>th</sup> (4:30pm)**. In order to withdraw from a class, students **MUST** request to be withdrawn by notifying the professor. This must be done **PRIOR** to the withdrawal deadline to receive a "W" grade. If a student does not request to withdraw before the deadline, the student must be assigned a letter grade that is earned by the end of the semester (A, B, C, D, and F). I urge any student who is contemplating of withdrawing from the class to see me first. You may be doing better than you think. Either way, I want to be accessible and supportive. I don't believe in "weed out" classes, and I consider you to be much more than just a name or number. ## **Course Withdrawals - First Time Freshman Students - Fall 2007 and Later**

Under Section 51.907 of the Texas Education Code "an institution of higher education may not permit a student to drop more than six courses, including any course a transfer student has dropped at another institution of higher education." This statute was enacted by the State of Texas in the Spring 2007 and applies to students who enroll in a public institution of higher education as a first - time freshman in fall 2007 or later. Any course that a student drops is counted toward the six - course limit if "(1) the student was able to drop the course without receiving a grade or incurring an academic penalty; (2) the student's transcript indicates or will indicate that the student was enrolled in the course; and (3) the student is not dropping the course in order to withdraw from the institution." Policies and procedures for implementation of this statute are being developed and will be published as soon as they are available.

HCC students affected by this statute that have attended or plan to attend another institution of higher education should become familiar with that institution's policies on dropping courses.

## Exercises

There will be exercises assigned after each class. In general, student who fail to do these assigned exercises do not do well in the course. All the exercises will be graded for credit. Students are strongly encouraged to attempt all exercises. The effort spent will enable you to perform better in tests and exams. All your exercises must be turned in as an attachment on Eagle On Line and also the hard copy printed out must be turned in.

Maximum of **15 points deduction** for each exercise turn in late after the due date. All exercises should be **individual effort, no copy from another students**, but students can assist each other.

## Exams and Make-up Policy

Examinations consist of three regular exams, a final drawing session and a compulsory final will be administered during the semester.

2). There will be final class drawing session made up of 10% of the final grade.

3). Make-up exams **will not** be given, so make every effort to take the exams on their scheduled dates.

Please note: 1) All students are required to take the final (no student can be exempted).

2) After the withdrawal date, no "W" can be given, and you **must** receive a regular grade (A-F) in the course.

**Grading Policy:** The final grade is based on the score out of 100% that the student accumulated from the three exams, Exercises, final Drawing Session and the final exam. Below is the weighting of the categories:

60% (20% for each Exam => 3x 20%)

15% Home works \_Exercises

10% Final Drawing session on **May 6, 2015**

15% Final exam on **May 11, 2015**

100% Total

The *overall score* is based on the following:

**Overall score = 0.60 (Average of three regular exams) + 0.15 (Homework) + 0.10 (Final Drawing Session) + 0.15 (Final Exams)**

The course grade is then obtained from the overall score:

Parallel Offsets, Drawing Points and using construction lines to assist in creating multiview drawings & auxiliary views

Commands: OFFSET, POINT, DDPTYPE, DIVIDE, MEASURE, XLINE, RAY

### **Chapter 12\_ Arranging and Patterning Objects**

Moving & copying objects, creating mirror images, aligning objects, arraying objects.

Commands: MOVE, ROTATE, ALIGN, COPY, MIRROR, REVERSE, ARRAY

### **Chapter 13\_ Grips, Properties and Additional Selection Techniques**

Using grips to edit objects, using the Properties palette, copying objects between drawings, matching properties, selection techniques.

Commands: PROPERTIES, MATCHPROP, ADDSELECTED, ADDSIMILAR, QSELECT

### **Chapter 14\_Polyline and Spline Editing Tools**

Editing polylines and splines, creating a polyline boundary.

Commands: BOUNDARY, PEDIT, SPLINEDIT

### **Chapter 15\_ Obtaining Drawing Information**

Obtaining information about the drawing, displaying information with fields, using the AutoCAD calculators to make mathematical calculations on numeric values.

Commands: MEASUREGEOM, LIST, DBLIST, TIME, STATUS, QUICKCALC

### **Chapter 16\_Dimension Standards and Styles.**

Drawing scale and dimensions, creating and using dimension styles, inserting conventional breaks, dimensioning practices and standards

Commands: SCALELISTEDIT, DIMSTYLE

## Chapter 17\_ Linear and Angular Dimensioning

Dimensioning lines and angles, drawing datum and Chain dimensions with QDIM

Commands: DIMLINEAR, DIMALIGNED, DIMJOGLINE, DIMANGULAR, DIMBASELINE, DIMCONTINUE, QDIM
