Course Description: Geology 1404 is the study of the history of the earth, its life forms and geologic time Laboratory includes the study of sedimentary rocks, fossils and geologic maps

Course Prerequisites: Geology 1403

Student Learning Outcomes (SLO): Students will be able to:

- * Explain the scientific method and how it relates to the earth
- * Explain the various ages of in geologic time
- * Identify evidence from the rock layer and how it is used to interpret earth history
- * Explain the theory of plate tectonics

<u>Attendance</u>: Mandatory

You are expected to attend all lecture classes and labs regularly. You are also responsible for materials covered during your absences. Attendance is recorded for each class- late entries are disruptive (**EACH** late=minus 2 point). **Makeup** assignments are due at the beginning of class when you return from your absence, therefore, you must email me to receive the assignment. No late assignments will be accepted unless I have given prior approval. Although it is your responsibility to drop a course for nonattendance, the instructor has the authority to drop you for excessive absences. You may be dropped from a course after accumulating absences in excess of 12.5 percent of the total hours of instruction (lecture and lab). For this 4 credit-hour lecture class meeting 6 hours per week, you can be dropped after 12 hours of absence.

<u>Religious Holidays: If you observe a religious holiday and miss class, please notify your instructor in advance to arrange to take a test or make up an assignment. A religious holiday is "a holy day observed by a specific religion and the place of worship is exempt from property taxation under Section 11.20 of the Tax Code."</u>

<u>Lab attendance is mandatory</u>. Lab exercises and assignments are designed to complement the lecture and give you hands-on experience with the concepts covered in lecture. Thinking through and understanding lab assignments is a big step toward learning the material. Collaborative group work is emphasized. You can learn from your classmates and them from you

ALL HOMEWORK ASSIGNMENTS ARE DUE AT THE BEGINNING OF CLASS. ASSIGNMENTS TURNED IN IN THE MIDDLE OR END OF CLASS ARE CONSIDERED LATE AND POINTS WILL BE DEDUCTED. If you are late to class then your assignment is also late.

(You are considered late 10 minutes after the designated printed class time)

Classroom Behavior: DISRUPTIVE BEHAVIOR WILL NOT BE TOLERATED and could result in a grade F. <u>Trash</u> <u>must be cleaned up at the end of class and chairs left in an orderly fashion</u>. <u>This is considered a part of your class</u> <u>participation grade, and points will be deducted for leaving a mess.</u>

Makeup Tests: Students will be allowed to make up a TEST **ONLY** if the student has contacted me prior to the test day for approval, and or there is an extreme emergency. **No student will be allowed to make up more than one (1) test per semester** (no exceptions) Make-up tests consists of a comprehensive 2-part test, immediately after your absence **Lab Policy:** Attendance is **mandatory** – There will be no make-up Lab work or make up lab tests. No late lab work will be accepted

Tests/Exams: The chapter tests will consist of a combination of Diagrams to label and interpret, matching, true/false, fill in the blank, word analysis, short answer, and one or two discussion questions. (NO MULTIPLE CHOICE QUESTIONS)

DO NOT LEAVE THE ROOM DURING A TEST. DO NOT USE A CELL PHONE DURING A TEST. Failure to take any test will result in a ZERO for that test score. If you do not take the final exam you will receive a grade of F for the course. Cheating on any test or the final exam will result in failure of the course (Semester Grade F) and referral to the Dean for further disciplinary action.

EXTRA CREDIT: DO NOT rely on EXTRA CREDIT to significantly improve your semester grade. It can help if you are on the borderline between two grades, however, it will not make a D average into an C average, a C average into a B average, or a B average into an A average. <u>Make sure you attend class, turn in homework, and study for tests so that you can earn the grade you want</u>

NO makeup work will be accepted starting with week 4 of the summer session. Uncompleted assignments will receive a grade of **Zero**

IP (In Progress) is given only in certain developmental courses. The student must re-enroll to receive credit. COM (Completed) is given in non-credit and continuing education courses

FINAL GRADE OF FX: Students who stop attending class and do not withdraw themselves prior to the withdrawal deadline may either be dropped by their professor for excessive absences or be assigned the final grade of "FX" at the end of the semester. Students who stop attending classes will receive a grade of "FX", compared to an earned grade of "F" which is due to poor performance. Logging into a DE course without active participation is seen as non-attending. Please note that HCC will not disperse financial aid funding for students who have never attended class.

Students who receive financial aid but fail to attend class will be reported to the Department of Education and may have to pay back their aid. A grade of "FX" is treated exactly the same as a grade of "F" in terms of GPA, probation, suspension, and satisfactory academic progress.

To compute grade point average (GPA), divide the total grade points by the total number of semester hours attempted. The grades "IP," "COM" and "I" do not affect GPA.
