Course Description

Identify major counseling theories; define and explain techniques relevant to the major theories; and discuss major approaches to treatment.

Prerequisites

Completion of developmental English classes or passing grades on the English portion of the college assessment exam.

Course Goals

This course is an examination of the major theories and current treatment modalities used in the field of human services.

End Of Course Outcomes

1. Identify major counseling theories

Students will be able to identify the major counseling theories by reviewing literature and answering basic questions from each chapter. Students will read case studies provided by instructor and decide best theory to apply.

- 2. Define and explain techniques relevant to the various theories. Student will participate in weekly discussions and will respond to another's thought concerning theories. Quizzes are administered on line for each theory. Assignments are given on each theory to identify techniques used that apply to that theory.
- 3. Identify major approaches to treatment. At the end of the course the student will be given 10 case studies to review and tell instructor if any of the methods in this course apply to that method.

Reasons given for each method will be listed by student and discussed by student.

Instructional Method:

As an instructor, I want my students to be successful. This is a distance education course which places much of the responsibility of your learning on you as a student. Instructor Requirements

As your Instructor, it is my responsibility to:

- Provide the grading scale and detailed grading formula explaining how student grades are to be derived

2 chances at each quiz- average score accepted (please note 1 attempt and second attempt are different) There is a 12 hour time limit between each attempt.

Discussions:

Discussions are there to promote interactions between students. There will be an original posting date as well as an end date for replies. Word count will be posted for each discussion when warranted. In order to receive the 50 points for your original post it must be done by the time posted in the discussion. You are eligible to receive 25 points for each reply up to 50 points. You must have an original post and respond to at least two discussions in order to get the full points. Your replies must a substantive response. Just saying I agree or you are right will not be enough. You must include why you agree or why you believe the way you believe.

I think I was able to change the dates on all the discussions. The first week original posting in the discussion will be Friday with a due date of 11:59 on Sunday. For weeks 2, 3, 4, the original posting date will be Thursday at 11:59 and a closing time of Sunday at 11:59. For week 5 the original posting time will be Tuesday at 11:59 with a closing date being Thursday at 11:59. I need to have time to grade assignments and discussions before grades are due.

Grading Scale

HCC Grading Scale

The Human Services Technology Program does not give Ds and any student earning a 69% or below will not be successful moved on to next skill level. Students must have a 3.0 grade point average in Human Services classes to apply for a practicum.

IP (In Progress) is given only in certain developmental courses. The student must re-enroll to receive credit. COM (Completed) is given in non-credit and continuing education courses. To compute grade point average (GPA), divide the total grade points by the total number of semester hours attempted. The grades "IP," "COM" and "I" do not affect GPA.

Student Attendance, 3-Peaters, Withdrawal deadline

The state of Texas imposes penalties on students who drop courses excessively. Students are limited to no more than 6 total course withdrawals throughout their education career at a Texas public college or universities. HCC charges a higher tuition for students registering for the third or subsequent time. If you wish to be withdrawn from your class this can be done on line anytime before withdraw due date or on a campus with a registrar. Pay special attention to the deadlines. At the end of the course if you have not officially withdrawn you will receive the grade you have earned.

In addition to tuition there is a \$24. Fee for each HCCS distance education class.
