#### **Course Description**

Business Law I is a weekly online course that examines various principles of law which form the legal framework for business activity. We will study applicable statues, contracts, and agency. This class was formerly called BUSI 2301.

#### Course Goal

Have students recognize, and be able to appropriately respond to, real-world areas of business law and regulations, thereby giving them competitive advantages as business leaders, as well as consumers.

IP (In Progress) is given only in certain developmental courses. The student must re- enroll to receive credit. COM (Completed) is given in non-credit and continuing education courses.

FINAL GRADE OF FX: Students who stop attending class and do not withdraw themselves prior to the withdrawal deadline may either be dropped by their professor for excessive absences or be assigned the final grade of "FX" at the end of the semester. Students who stop attending classes will receive a grade of "FX", compared to an earned grade of "F" which is due to poor performance. Logging into a DE course without active participation is seen as non-attending. Please note that HCC will not disperse financial aid funding for students who have never attended class.

Students who receive financial aid but fail to attend class will be reported to the Department of Education and may have to pay back their aid. A grade of "FX" is treated exactly the same as a grade of "F" in terms of GPA, probation, suspension, and satisfactory academic progress.

To compute grade point average (GPA), divide the total grade points by the total number of semester hours attempted. The grades "IP," "COM" and "I" do not affect GPA.

This course will be presented as an online course. All assignments and exams will be taken online. Students should plan accordingly. Because the course is entirely online, students should be familiar with the internet, and comfortable in working through it. A broadband connection is strongly encouraged. If a student does not have a broadband connection, consider using the school's facilities or a local library to complete exams.

To be successful in this course, a student should have a reasonable degree of computer literacy and

typing skills. The course requires an extended degree of reading, writing and analysis. Finally, an online course requires a great deal of commitment and self-discipline on the part of the student. Since this is a compressed schedule students should expect to spend at least 6-10 hours per week in mastering the course content and fulfilling requirements.

#### **METHOD(S) OF EVALUATION:**

Students will access and submit all assignments through the internet, primarily Canvas. Instructions will accompany each assignment. Exams will be taken online, as indicated on the Syllabus.

This course has a web page established on HCC's Canvas. Through Canvas, students will be able to:

- E-mail the instructor and other students.
