<b>Instructional Methods</b>	Face to Face with an element of online
Student Assignments	The class is divided into 16 Modules; one module for each week of class. Each week, you should begin a new module and complete all assignments and exams within the module.
	Assignments are designed to stimulate critical thinking, and reinforce key concepts. Students receive immediate feedback and can track their progress in their own report.
	Exams are used to test your retention of the lessons from the text and assignments.
	Some modules contain extra credit assignments, which could help gain you points at the end of the semester.
Student Assessment(s)	There are 4 assignments and 4 exams which will be a combination of Interactive exercises, True and False questions, Multiple Choice and Fill in the Blanks.

Instructor's Requirements	Students <u>must</u> complete assignments through Canvas.
	Students are expected to maintain a state of <b>technical compliance</b> , including (but not limited to): up-to-date software as required by the instructor; a stable Internet connection; and use of the Firefox browser when using Canvas.
	The instructor is NOT required to give consideration for lost/missing/unacceptable work stemming from technical non- compliance and/or end-user technical issues.
	Deadlines must be adhered to strictly. This is a standard for all institutions, HCC college policy, and that of every instructor. Tests and Assignments MUST be submitted through Canvas (not MH connect). If it is locked out, you missed it!

IP (In Progress) is given only in certain developmental courses. The student must re-enroll to receive credit. COM (Completed) is given in non-credit and continuing education courses. To compute grade point average (GPA), divide the total grade points by the total number of semester hours attempted. The grades "IP," "COM" and "I" do not affect GPA.

**FINAL GRADE OF FX:** Students who stop attending class and do not withdraw themselves prior to the withdrawal deadline may either be dropped by their professor for excessive absences or be assigned the final grade of "FX" at the end of the semester. Students who stop attending classes will receive a grade of "FX", compared to an earned grade of "F" which is due to poor performance. Logging into a Canvas but not coming to class is seen as non-attending. Please note that HCC will not disperse financial aid funding for students who have never attended class. Students who receive financial aid but fail to attend class will be reported to the Department of Education and may have to pay back their aid. A grade of "FX" is treated exactly the same as a grade of "F" in terms of GPA, probation, suspension, and satisfactory academic progress.

A grade of "I" (incomplete) will be considered only for those students who have completed at least 80% of quizzes, exams, and assignments with a passing grade of "C" or above. Only students who are unable to complete the class because of illness or other extraordinary circumstance may receive an "I". Students must immediately notify the instructor prior to the end of the semester for consideration of receiving an "I". Remember you must have completed 80% of the course work and in all cases, regardless of circumstances, the instructor reserves the right to refuse to award an "I".
