# **Physical Education and Health Mission Statement:**

## **Course Description:**

Instruction and practice for emergency care. Designed to enable students to recognize and avoid hazards within their environment, to render intelligent assistance in case of accident or sudden illness, and to develop skills necessary for the immediate and temporary care of the victim. Successful completion of the course may enable the student to receive a certificate from a nationally recognized agency. This course fulfills the New Core 2014 requirement under the Component Area Option.

# **Learning Outcomes:**

#### **Program Student Learning Outcomes/Objectives:**

- 1. Students will perform physical skills to improve and enhance cardio-respiratory, strength, endurance, flexibility, and/or balance as measured with a departmental field exam.
- Students will develop broad content knowledge within the discipline of health/physical education associated with good health management, health risks and/or disease prevention.
- 3. Students will demonstrate an understanding of basic safety/emergency procedures.
- 4. Conduct a personal wellness appraisal and utilize data results to determine potential health impacts and appropriate intervention activities.

### **Course Student Learning Outcomes/Objectives:**

#### Upon successful completion of this course, students will:

- 1. Explain the workings of the systems in human body particularly those systems, which are likely affected in emergency care.
- 2. Recognize and meet the needs of emergency situations including but not limited to first aid care, emergency assistance, life support skills, EMS protocols, CPR, and AED.
- 3. Justify layperson and professional roles and responsibilities in emergency situations including but not limited to legal ramifications, barriers to action, requirements for action, and psychological responses.
- 4. Explain and demonstrate skills for treating victims including but not limited to musculoskeletal injuries, bleeding, choking, and environmental emergencies.
- 5. Explain and demonstrate skills for respiratory distress including but not limited to CPR, rescue breathing, obstructed airway, and usage of an AED device.
- 6. Promote safety and preventative educational methods that reduce the risk of injury, accidents, and life-style related diseases.

# **Core Curriculum Competencies:**

Given the rapid evolution of necessary knowledge and skills and the need to take into account global, national, state, and local cultures, the core curriculum must ensure that students will develop the essential knowledge and skills they need to be successful in college, in a career, in their communities, and in life. Through the Texas Core Curriculum, students will gain a foundation of knowledge of human cultures and the physical and natural world, develop principles of personal and social responsibility for living in a diverse world, and advance intellectual and practical skills that are essential for all learning.

Students enrolled in this core curriculum course will complete several essays, including at least one oral presentation, designed to cultivate the following core objectives:

- **Critical Thinking Skills** to include creative thinking, innovation, inquiry, and analysis, evaluation and synthesis of information
- **Communication Skills** to include effective development, interpretation and expression of ideas through written, oral and visual communication
- **Quantitative and Empirical** to include the manipulation and analysis of numerical data or observable facts resulting in informed conclusions
- Social Responsibility to include intercultural competence, knowledge of civic responsibility, and the ability to engage effectively in regional, national, and global communities

Student proficiency in Communication and Critical Thinking skills will be assessed through written, oral, and manual demonstration of skills needed for an emergency situation. Student proficiency in Quantitative and Empirical Literacy will be assessed through a series of essay questions. Social Responsibility will be assessed by a 500 word reflection paper about their civic responsibilities.

**IP** (In Progress) is given only in certain developmental courses. The student must re-enroll to receive credit. COM (Completed) is given in non-credit and continuing education courses.

**FINAL GRADE OF FX**: Students who stop attending class and do not withdraw themselves prior to the withdrawal deadline may either be dropped by their professor for excessive absences or be assigned the final grade of "FX" at the end of the semester. Students who stop attending classes will receive a grade of "FX", compared to an earned grade of "F" which is due to poor performance. Logging into a DE course without active participation is seen as non-attending. Please note that HCC will not disperse financial aid funding for students who have never attended class.

Students who receive financial aid but fail to attend class will be reported to the Department of Education and may have to pay back their aid. A grade of "FX" is treated exactly the same as a grade of "F" in terms of GPA, probation, suspension, and satisfactory academic progress.

To compute grade point average (GPA), divide the total grade points by the total number of semester hours attempted. The grades "IP," "COM" and "I" do not affect GPA.

#### **Skills Test and Written Skills Exam:**

All students will be presented with an emergency scenario in which they will orally and manually perform skills needed for the scenario presented. During the skills assessment, the students will need to be able to verbalize and perform the proper skills based on the scenario. Written communication will be assessed through a short assignment of 500 words. This assignment deals with the steps of evaluating an unconscious or conscious victim and providing the appropriate care. Communication and Critical Thinking will cumulatively be valued at 15% of the final course grade.

#### **Quantitative/Empirical Essay:**

Students will answer a series of essay questions presented to them. Essay questions will require students to draw conclusions bases on systematic analysis of the data provided. Quantitative and Empirical Literacy will be valued at 5% of the final course grade.

#### Social Responsibility Essay:

In culmination of the semester, students will write a 500 word reflection essay about their civic responsibility to help others within their community. Social Responsibility will be valued at 5% of the final course grade.

#### Make Up Policy:

The tests — skills and written — will cover all material covered in the course. This includes handouts, lectures, demonstrations, and discussions. *No make ups or extra credit will be given.* Failing to take an exam will result in a "0" for the grade. This also pertains to the Skills Test Days.

#### **CPR/First-Aid Certificates:**

Successful completion of 80% or greater on all Exams and Assignments is required to obtain certification. Certification Certificates are available upon request and for a small fee.

<u>CPR requires strenuous effort. If a person has any concerns about how this may affect their</u> <u>health, they should consult a physician before coming to class.</u>

Students are expected to maintain a state of technical compliance, including (but not limited to):

- up-to-date software as required by the instructor;
- a stable Internet connection;

#### **Academic Honesty**

A student who is academically dishonest is, by definition, not showing that the coursework has been learned, and that student is claiming an advantage not available to other students. The instructor is responsible for measuring each student's individual achievements and also for ensuring that all students compete on a level playing field. Thus, in our system, the instructor has teaching, grading, and enforcement roles. You are expected to be familiar with the University's Policy on Academic Honesty, found in the catalog. **Cheating** on a test includes:

• Bribing another person to obtain a test that is to be administered.

**<u>Plagiarism</u>** means the appropriation of another's work and the unacknowledged incorporation of that work in one's own written work offered for credit.

**Collusion** means the unauthorized collaboration with another person in preparing written work offered for credit. Possible punishments for academic dishonesty may include a grade of 0 or F in the particular assignment, failure in the course, and/or recommendation for probation or dismissal from the College System. #### **Class Attendance**

**It is important that you come to class!** You are encouraged to attend each class since regular attendance correlates with good grades. Be on time and attend the entire class.
