<b>A.14 Course Description</b>	<p>PSYC 2301 is a survey course of the basic principles underlying human behavior. Emphasis is placed on major areas of study in the field of psychology, such as motivation, development, thought processes, personality.</p>
<b>A.15 Prerequisites</b>	<p>PSYC 2301 requires college-level reading and writing skills. Research indicates that you are most likely to succeed if you have already taken and passed ENGL 1301. The minimum requirements for enrollment in PSYC 2301 include placement in college-level reading (or take INRW 0420 or ESOL 0360 as a co-requisite). If you have enrolled in this course without having satisfied these prerequisites, you are at higher risk of failure or withdrawal than students who have done so, and you should carefully read and consider the repeater policy in the <a href="#">HCC Student Handbook</a>.</p>

**D.1 Exams**

**D.2 Written Assignment(s)**

A Written assignment is required and will count as 10% of your grade. There will be one (1) separate written essay; Each essay will be worth 100 points out of a 1000 points. The essays will address the application and analysis of the material discussed in class. Written assignments should be in APA Style with a maximum of 5 pages, not including the cover sheet.

**Written Assignment Article Summary**

The purpose of this assignment is for you to spend time examining information in the field of psychology. You are to choose an interesting and applicable article and write a maximum two-page summary of the article, plus a cover sheet. The article may be from the internet, a journal, or a magazine.

No handwritten summaries will be accepted.</li> <li>✓ Use 1 inch margins all around.</li> <li>✓ Use 12 pt. font.</li> <li>✓ Cover page must be included and contain your name, class, title of paper.</li> <li>✓ Upload your article to <b>Turnitin</b>. No paper will be accepted without the article.</li> <li>✓ Use paragraph breaks, proper grammar, correct spelling, and a formal writing style.</li> <li>✓ Use each of the above questions as a heading.</li> <li>✓ All written assignments must be typed and checked for grammatical, syntax, and spelling errors.
